The bidder will not be allowed to participate in the e-Auction in case of non uploading of required Demand Drafts (DD's).

GENERAL INFORMATION FOR BIDDERS

1. The bidder scan download the e-Auction document from the Portal : <https://eauction.gov.in>.
2. The in tending bidders, before participate on in the Online Auction/bidding process will be required to create their user ID and password at i.e. <https://eauction.gov.in>.

Steps to create user ID and password:-

- Go to Online bidder Enrolment link ateauction.gov.in
 - Fill all the required in formation at online bidder enrolment page.
 - After successfully creation of user ID and password of intending bidder required to login in eauction.gov.in.
 - Link Digital Signature Certificate (D.S.C.) with in tending bidder' sac countate eauction.gov.in.
 - After Successful completion of above said points, the bidder will be able to go at their home page screen at eauction.gov.in and bidder can participate in e-auction.
3. For participation in Online Auction, He/She will be required to make offline payment of e-Service Fee& Participation Fees as per details provided on Page No.1. The bidder who fails to paye-Service Fee& Participation fees within the stipulated period shall not be allowed to participate in the Online Auction.
 4. The Bidders shall have to pay e-Service Fee in the shape of Demand Draft (DD) in favor of "Society for it initiative fund for E-Governance" and Participation Fees i.e. Earnest Money Deposit (EMD) shall have to deposit in the shape of demand draft in favor of City Magistrate, Faridabad payable at Faridabad. Both Demand Drafts (DD's) are to be deposited in the office of District Nazar, Faridabad by due date & time.
 5. The interested bidders shall have to pay mandatorily thee-Service fee and Participation Fees i.e. Earnest Money Deposit (EMD) by bidders through Demand Draft(s) and photocopies of the Demand Draft(s) also have to be uploaded on e-Auction portal. After verification of the said demand draft (s) the department will have to approve the same in e-Auction portal, failing which the bidder will not be able to participate in the online auction.

TERMS AND CONDITIONS FOR ONLIN EAUTION

Sr. No.	Details
1.	The various model of Condemned vehicles, will be sold on "AS IS WHEREISBASIS" & "AS IS WHATITISBASIS".
2.	Eligibility of participation in online auction:- <ol style="list-style-type: none"> I. Only Registered firm with GST no and GST return up dated for current period. II. The firm must have annual turnover more 10 Lacs in the current and previous financial year.
3.	Validity of Bid:- The validity of the offer will be for a period of <u>15 days</u> from the closing date of the online Auction.
4.	<u>G.S.T.@18%,@28%</u> or as applicable from time to time shall be charged extra from the Successful bidder. The G.S.T. deposited once will not be refunded in any circumstance.
5.	It is the so le responsibility of the bidder to inspect the vehicles physically before participating in the Online Auction for the same.
6.	The Registration certificate will be given to the successful bidder, if applicable, as per Govt. Instructions.
7.	Bid incremental value:- The minimum bid incremental value will depend upon the category of vehicles/items available for auction. <ol style="list-style-type: none"> (a) In case of Four Wheeler and above, like Car, Jeep, Bus, Truck etc., the minimum bid incremental value will be Rs. 1,000/- (One Thousand only) per vehicle. (b) In case of Two Wheeler like Motorcycle/Scooter/Goods etc., the minimum bid incremental value will be Rs. 500/- (Five Hundred only) per vehicle.
8.	Decision of Auction:- The decision of the e-Auction will be as under:- <ol style="list-style-type: none"> a. SDO Mechanical Division PWD B&R Faridabad (Member) The above committee reserves the right to accept/reject any bid without assigning any reason thereof. b. Acceptance letters for rates shall be sent to the success full bidders on their registered e- mail IDs along with a copy of Intending Department.
9.	Deposit of Sale Value of the Vehicles/other items:- The successful bidder will have to deposit the sale value of the Vehicle, Condemned etc. mentioned in the acceptance letter issued by the concerned Department/Govt. Agency within 03 working days (up to 5.00PM of last working days) from the date of issue of acceptance letter of their highest quoted rate.
10.	Deposit of G.S.T.:- The successful bidder will have to deposit GST@18%,@28%oras applicable from time to time of the Sale Value as under: <ol style="list-style-type: none"> (a) 2 Wheeler (Motorcycle/Scooter etc.), 3 Wheeler (Auto etc.),4 Wheeler (Car, Jeep etc.) & above (Bus, Truck etc.): <ol style="list-style-type: none"> i. 11.	Release Order for Vehicles/other items:- On receipt of documentary proof of deposit of Sale Value and G.S.T. @18%, @ 28% or as applicable from time to time, the Intending Department will issue release order of Vehicle/other items to the purchaser. The purchaser shall have to lift the vehicles/other items within 10 days after issuance of release order. No grace period will be granted to the purchaser. If the purchaser fails to lift the vehicle/other items within 10 days a penalty @1% of the sale value will be charged extra. However, in case of any justified reason concerned Additional Deputy Commissioner will have discretion to extend the lifting Period up to further 3 days without any penalty.
12.	Place of Delivery:- Consignee's site on "AS IS WHERE IS BASIS" & "AS IS WHAT IS BASIS".
13.	Retaining/Not Retaining of Registration No. of Vehicle:- It is the sole discretion of the intending department as to whether they wish to retain the Registration No. of the vehicle or not. (a) If the intending department retains the Registration No. of the vehicles then new number will be provided by the concerned department at the time of transfer of the Registration Certificate (RC). (b) If the intending department allows transferring of the Registration No. of the vehicles to the bidder then the bidder has to deposit the requisite Govt. Fees to the Transport Department for obtaining the particular number at the time of transfer of the Registration Certificate (RC).
14.	Refund of Participation Fees (EMD):- The amount will be refunded through <u>Demand Draft(DD)/Cheque/NEFT/RTGS</u> to the unsuccessful bidder: - (a) In case of unsuccessful bidders (whose rates are not Highest), the demand draft of the participation fees (EMD) will be returned within 30 days from the closing date of Online Auction through <u>Demand Draft(DD)/Cheque /NEFT/RTGS</u> . (b) In case of successful bidders whose rates have been accepted and acceptance letter has been issued to the bidder, their Participation Fees (EMD) shall be retained till completion of payment process. Once the successful bidder deposits the Sale Value of the Vehicle/other items along with <u>G.S.T.@18%,@28%</u> or as applicable time to time within the specified time period and finally the release order of the vehicle and other items is issued in their favor, their Participation Fees (EMD) shall be automatically Refunded through electronic mode directly in their accounts as per details provided by them.

For feature of Participation Fees(EMD):- (a) Before closing of the e-Auction i.e. during the bidding process:-Participation Fees (EMD) will be forfeited if the bidder withdraws or amends the rates under any circumstances. (b) After issuance of the Acceptance Letter:- Participation Fees i.e. Earnest Money Deposit (EMD) will be forfeited if the bidder fails to deposit the requisite Sale Value of Vehicle and other items along with G.S.T. @ 18%, @28% or as applicable time to time within the stipulated period after issuance of the acceptance letter in his/her favor.
