5.	After depositing of e-Service Fee, bidder is required to deposit Participation Fees i.e. Earnest Money Deposit (EMD). IMPORTANT NOTE(S)

1. The Bidders can only participate by signing-up online (creating user account) on NIC e-Auction Portal i.e.<https://eauction.gov.in>.
2. The photocopy of Demand Draft (DD) of e-Service fee and participation fees is required to upload on the e-Auction portal before 03 working days (upto11.00 AM of last working day) of scheduled e-Auction date. The bidder will not be allowed to participate in the e-Auction in case of non e-uploading of required Demand Drafts (DD's).

GENERAL INFORMATION FOR BIDDERS

1. The bidders can download the e-Auction document from the Portal: <https://eauction.gov.in>.
2. The intending bidders, before participation in the Online Auction/bidding process will be required to create their user ID and password at i.e. <https://eauction.gov.in>.

Steps to create user ID and password:-

- Go to Online bidder Enrollment link at eauction.gov.in
- Fill all the required information at online bidder enrollment page.
- After successfully creation of user ID and password of intending bidder required to login in eauction.gov.in.
- Link Digital Signature Certificate(D.S.C.) with intending bidder's account at eauction.gov.in.
- After Successful completion of above said points, the bidder will be able to go at their home page screen at eauction.gov.in and bidder can participate in e-auction.

3. For participation in Online Auction, He/She will be required to make offline payment of e-Service Fee & Participation Fees as per details provided on Page No.1. The bidder who fails to pay e-Service Fee & Participation fees within the stipulated period shall not be allowed to participate in the Online Auction.
4. The Bidders shall have to pay e-Service Fee in the shape of Demand Draft (DD) in favour of "**Society for it initiative fund for E-Governance**" and Participation Fees i.e. Earnest Money Deposit (EMD) shall have to depositing the shape of demand draft in favour of **Deputy Commissioner, Kurukshetra** payable at **Nazar Branch, Room No. 225, Office of Deputy Commissioner, Kurukshetra**. Both Demand Drafts (DD's) are to be deposited in the office of **Deputy Commissioner, Kurukshetra**, by due date & time.
5. The interested bidders shall have to pay mandatorily the e-Service fee and Participation Fees i.e. Earnest Money Deposit (EMD) by bidders through Demand Draft(s) and photocopies of the Demand Draft(s) also have to be uploaded on e-Auction portal. After verification of the said demand draft(s) the department will have to approve the same in e-Auction portal, failing which the bidder will not be able to participate in the online auction.

TERMS AND CONDITIONS FOR ONLINE AUCTION

Sr. No.	Details
1.	The vehicles and Condemned /Unserviceable Spare parts, Tyres, Tube & flaps, used mobil-oil and Iron Scrap etc.will be sold on “AS IS WHERE IS BASIS”&“AS IS WHAT IT IS BASIS”.
2.	Eligibility of participation in online auction:- Any Registered Firm with GST No. can participate in online auction.
3.	Validity of Bid: - The validity of the offer will be for a period of <u>15 days</u> from the closing date of the online Auction.
4.	G.S.T. @ 18%, as applicable from time to time shall be charged extra from the successful bidder. The G.S.T. deposited once will not be refunded in any circumstance.
5.	It is the sole responsibility of the bidder to inspect the vehicles/Spare parts, Tyres,Tube & flaps, used mobil-oil and Iron scrap etc. physically before participating in the Online Auction for the same.
6.	The Registration certificate will be given to the successful bidder, if applicable, as per Govt. Instructions.
7.	<p>Bid incremental value:- The minimum bid incremental value will depend upon the category of vehicles/items available for auction.</p> <p>(a) In case of Three Wheeler and other Vehicles, like Car, Jeep, Bus, Truck etc., the minimum bid incremental value will be Rs. 1,000/- (One Thousand only) per vehicle.</p> <p>(b) In case of Two Wheeler like Motorcycle/Scooter etc., the minimum bid incremental value will be Rs. 200/- (Two Hundred only) per vehicle.</p> <p>(c) i. In case of Condemned /Unserviceable Spare parts, iron scraps, brass and aluminum Parts bearing all kind and the items which are measured by weight etc. the minimum bid incremental value will be Rs. 100/- (One Hundred only) per Qtl. ii. In case of used mobil-oil and the items which are measured by volume the minimum bid incremental value will be Rs. 500/- (Five Hundred only) per KL. iii. Acceptance letters for rates shall be sent to the successful bidders on their registered e-mail IDs along with a copy of Intending Department.</p>
9.	Deposit of Sale Value of the Vehicles/other items: - The successful bidder will have to deposit the sale value of the Vehicle, Condemned/Unserviceable Spare parts, condemned Tyres, Tube & flaps, used mobil-oil and Iron Scrap, etc. mentioned in the acceptance letter issued by the concerned Department/Govt. Agency within 03 working days (upto 5.00PM of last working days) from the date of issue of acceptance letter of their highest quoted rate.
10.	<p>Deposit of G.S.T.:- The successful bidder will have to deposit GST @18%, as applicable from time to time of the Sale Value as under:</p> <p>(a) 2 Wheeler (Motorcycle/Scooter etc.), 3 Wheeler (Auto etc.), 4 Wheeler (Car, Jeep etc.) & above (Bus, Truck etc.):</p>

The purchaser shall have to lift the vehicles/other items within 10 days after issuance of release order. No grace period will be granted to the purchaser. If the purchaser fails to lift the vehicle/other items within 10 days a penalty @ 1% of the sale value will be charged extra. However, in case of any justified reason concerned General Manager will have discretion to extend the lifting period upto further 3 days without any penalty.</p>

13.	<p>Retaining/Not Retaining of Registration No. of Vehicle:-</p> <p>It is the sole discretion of the intending department as to whether they wish to retain the Registration No. of the vehicle or not.</p> <p>(a) If the intending department retains the Registration No. of the vehicles then new number will be provided by the concerned department at the time of transfer of the Registration Certificate (RC).</p> <p>(b) If the intending department allows transferring of the Registration No. of the vehicles to the bidder then the bidder has to deposit the requisite Govt. Fees to the Transport Department for obtaining the particular number at the time of transfer of the Registration Certificate (RC).</p>
14.	<p>Refund of Participation Fees (EMD):- The amount will be refunded through <u>Demand Draft(DD)/Cheque/NEFT/RTGS</u> to the unsuccessful bidder: -</p> <p>(a) In case of unsuccessful bidders (whose rates are not Highest), the demand draft of the participation fees (EMD) will be returned within 30 days from the closing date of Online Auction through <u>Demand Draft(DD)/Cheque /NEFT/RTGS</u>.</p> <p>(b) In case of successful bidders whose rates have been accepted and acceptance letter has been issued to the bidder, their Participation Fees (EMD) shall be retained till completion of payment process.
