3. For participation in Online Auction, he/she will be required to make offline payment of e-Service Fee & Participation Fees as per details provided on Page No.1. The bidder who fails to pay e-Service Fee & Participation fees within the stipulated period shall not be allowed to participate in the Online Auction.
