Violent protests in Paris as teen shot dead by cop

Shot in the chest from a point blank range during traffic stop in western Paris suburb

PARIS

FRANCE braced for more angry protests on Wednesday after the killing of a teenager by police during a traffic stop that President Emmanuel Macron called "unforgivable".

The government said it would deploy 2,000 riot police to deal with any unrest, a day after a 17-year-old was shot in the chest by a police officer who then appeared to lie about the circumstances of the killing.

The shooting had already sparked unrest in several Paris suburbs overnight.

Celebrities and politicians expressed outrage and grief at the death of the teenager. Macron called it "inexplicable" and "unforgivable".

The teenager, named only as Nahel M, was pulled over by two policemen on Tuesday for breaking traffic rules, prosecutors said.

Police initially reported that one officer had shot at the teenager because he was driving his car at him, but this version of events was contradicted by a video circulating on social media and authenticated by

The footage shows the two policemen actually standing by the side of the stationary car, with one pointing a weapon at the driver. A voice is heard saying, "You are going

to get a bullet in the head." The police officer then appears to fire

point blank as the car abruptly drives off. The car moved a few dozen metres before crashing. The driver died shortly after. His death sparked immediate protests in Nanterre, a western

Paris suburb, the scene of the shooting. Bins were set alight and a fire broke out at a music school,

while police tried to disperse the protesters with tear gas. Protests then spread to some neighbouring suburbs. Interior Minister Gerald Darmanin said Wednesday that 31 people had been arrested overnight, 24 police slightly injured and around 40 cars torched. "A teenager was killed. That is inexplicable and unforgivable," President Emmanuel Macron said during an official visit to Marseille, southern France. The case had "moved the entire nation", he said,

Prime Minister Elisabeth Borne tweeted she hoped that "our absolute demand for the truth will allow calm to prevail over anger".

10 killed in Russian attack on Ukraine pizzeria, 61 injured

UKRAINIAN authorities arrested on Wednesday a man they accused of helping Russia direct a missile strike that killed at least 10 people, including three teenagers, at a popular pizza restaurant in eastern part of Ukraine.

The attack on Tuesday evening in Kramatorsk wounded 61 other people, Ukraine's National Police said, in the latest bombardment of a Ukrainian city, a tactic Russia has used heavily in the 16-month-old war. The strike, and others elsewhere across Ukraine late on Tuesday and early Wednesday, indicated that the Kremlin is not easing its aerial onslaught despite its political and military turmoil caused by a short-

lived uprising last weekend. There has been no apparent military push by Ukraine to exploit that turmoil, though the government has been tightlipped about recent battlefield developments as it seeks to

gain momentum in its recently launched counteroffensive. The Kremlin reeled from the weekend mutiny led by Yevgeny Prigozhin, owner of the Wagner private army of prison recruits and other mercenaries which has played a key role for Russia in Ukraine. The rebellion was the gravest threat so far to Russian President Vladimir Putin's grip on power. Prigozhin went into exile in neighbouring Belarus on Tuesday, according to Belarus President Alexander Lukashenko, after Russia said he wouldn't face charges for the revolt.

Prigozhin's whereabouts could not be independently confirmed. Two sisters, both age 14, died in the Kramatorsk attack, the city council's educational department said.

"Russian missiles stopped the beating of the hearts of two angels," it said in a Telegram post. The other dead teenager was 17, according to Prosecutor General Andrii Kostin.

The attack also damaged 18 multistory buildings, 65 houses, five schools, two kindergartens, a shopping center, an administrative building and a recreational building, regional Governor Pavlo Kyrylenko said. Rescuers are still searching the rubble for bodies and more survivors.

Officials initially blamed the strike in Kramatorsk on an S-300 missile, a surface-to-air weapon that Russia's forces have repurposed for loosely targeted strikes on cities, but the National Police later said Iskander short-range ballistic missiles were used.

Swedish police

lets man burn

copy of Quran

A man set fire to several pages of the Quran outside Stockholm's main mosque on Wednesday, after Swedish police granted a permit for the protest which coincided with the start of the Muslim holiday Eid al-Adha. Police said in its written decision that the secu-

rity risks associated with the burning "were not of a nature that could justify, under current laws, a decision to reject the request." The protest unfolded calmly.

Salwan Momika, 37, who fled from Iraq to Sweden several years ago, had asked police for permission to burn the holy book "to express my opinion

about the Quran." Ahead of the protest, Momika told news agency TT he also wanted to highlight the importance of freedom of speech.

Under a heavy police presence and with around a dozen opponents shouting at him in Arabic, Momika addressed the crowd of several dozen through

At various times, he stomped on the Quran, put strips of bacon in it, lit a few pages on fire before slamming it shut, and kicked it like a football, while waving Swedish flags.

Turkey's foreign minister condemned the burning of several pages from the Quran in Sweden as "vile" and "despicable.'
