#### Public Notice for Sale of Bank's Vehicles

It has been decided by the competent authority to dispose Bank's old vehicles on "**as is where is basis**" (The details of which are given in Annexure-I) under open tender process and vehicle/s will be sold to "**the highest successful bidder**" depending on price quoted for the vehicle list in Annexure-I. Accordingly, sealed offers are invited in the prescribed format only.

2. The vehicles are available for inspection at Bank of India, Navi Mumbai Zonal Office, **MDI Building, Plot No. 30, Sector-11, CBD Belapur, Navi Mumbai-400614** between **10.00 a.m. to 3.00 p.m. from Monday to Friday from 12<sup>th</sup> December, 2025 till 01<sup>st</sup> January, 2026**. No test drive of vehicles is permitted. Offer(s) should be submitted in sealed envelope(s) super scribing "**TENDER FOR PURCHASE OF BANK'S VEHICLE(s)**" along with an Earnest Money Deposit (EMD) of Rs.10,000/- ( Rupees ten thousands only) for each vehicle by Demand Draft / Pay Order favoring Bank of India payable at Mumbai. The tender application(s) should be dropped in the tender box kept at the Navi Mumbai Zonal Office, MDI Building, Plot No. 30, Sector-11, CBD Belapur, Navi Mumbai-400614 till **3.00 p.m on or before 01<sup>st</sup> January, 2026**. No tenders will be accepted after 03:00 PM of January 1, 2026. Bank won't accept any tender by hand, all the tender packet(s) to be dropped in the tender box only.

#### 3. The terms and conditions of sale are as follows:

- The vehicle(s) shall be sold on "as is where is basis".
- Applicant intending to apply for multiple vehicles have to submit "**separate tender for each vehicle and separate tender should contain separate EMD amount**". Single combined application for more than one vehicle would lead to rejection of the bid.
- The applicant have to submit photo copy of his **AADHAR**(or any other document with residence address), **PAN card**(Udyam Certificate/Shop Establishment Act Certificate or any other document in case Firms or Agencies as the case may be) and **EMD** in the form of original Demand Draft/Pay Order with his application. **It is mandatory for the applicant to show the original ID Cards for verification either during Tender Opening Process or on before 05-01-2026(before 05:00 PM)**. Non-submission may lead to rejection of the bid.



- **Vehicle(s) will be transferred “in the name of the offerer only” against full payment and all expenses for transfer will be borne by offerer only.**
- EMD amount shall be forfeited if the successful bidder fails to deposit the remaining amount fulfilling his bid value within 07(Seven) bank working days from the date of intimation. Non-submission of the same might lead to rejection of the bid.
- The Earnest Money Deposit (EMD) in form of DD/Pay Order favoring Bank of India payable in Mumbai to be issued by scheduled commercial banks only. The EMD of unsuccessful bidders shall be returned to them within 02 weeks from the date of completion of tender process.
- Separate sealed cover(s) should be submitted by quoting rate(s) for each vehicle separately. Cover containing combined offers, received in open condition would be rejected.
- **Vehicle would be delivered to the purchaser(s) only after name of ownership is transferred in the name of purchaser in the RTO.** The vehicles have to be taken hand over within 30 days of deposition of the full amount and after completing all RTO formalities.
- Officers who are entitled for Bank's vehicle are not allowed to participate in this tender process.
- **The Bank reserves the right to sell all 03 or less number of vehicle(s) depending upon floor price fixed by the Bank. The Bank also reserves the right to reject/accept any/all offer(s) without giving any reason(s) thereof.**
