**NOTICE FOR SALE OF IMMOVABLE PROPERTY ISSUED UNDER THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT 2002, (Hereinafter referred to as Act) R/w SECURITY INTEREST (ENFORCEMENT) RULES, 2002 (hereinafter referred to as Rules).**

Whereas the Authorized Officer of the Federal Bank Limited, under the Act, issued a demand notice dated 16/04/2021, calling upon the borrowers and defaulters, 1) Mr. Dalsingar Gupta and 2) Mr. Pradeep Dalsingar Gupta having address at Flat No: E 307, 3<sup>RD</sup> Floor, Shakuntala Sankalp, Kalyan, Dombivli East, Thane – 421204, Maharashtra to repay the amount mentioned in the notice being Rs.26,83,657/- (Rupees Twenty Six Lakhs Eighty Three Thousand Six Hundred Fifty Seven Only) together with interest and costs within 60 days from the date of receipt of the said notice being the amount due under Federal Housing Loan with Loan Account number loan A/c no: 13697300003587 availed by the borrowers.

Whereas the borrower's having failed to repay the amount within the stipulated time, the Authorized Officer on behalf of the Federal Bank Limited has taken **physical possession** of the property described herein below in exercise of powers conferred under section 13(4) of the said Act read with rule 8 of the said Rules on **16<sup>h</sup> Day of April 2025** by issuing a notice to the borrowers and general public and publication thereof in newspapers as contemplated under the said Act and Rules.

The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on 02/01/2026, the property described herein below on "AS IS WHERE IS" "AS IS WHAT IS" & "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realizing the dues of Rs.36,44,359.80 (Rupees Thirty Six Lakhs Forty Four Thousand Three Hundred Fifty Nine and Paise Eighty Only) as on 26/08/2024 (claim amount as per Original Application filed before Hon'ble Debt Recovery Tribunal – 3, Mumbai vide Diary No.1534 of 2024 on 04/09/2024) along with further interest, charges and cost thereon from 26/08/2024 due from the borrowers under housing loan account No 13697300003587 with Branch: Mumbai/ Vashi of The Federal Bank Limited and thus the undersigned hereby invites tenders/e-bids from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

6. The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank account no. A/c No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.2,95,000/- (Rupees Two Lakhs Ninety Five Thousand Only), before 3.00 PM on 01/01/2026, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
7. The incremental Bid amount will be in the multiple of Rs.5,000.00 (Rupees Five Thousand Only).
