

# VOTE CHORI CHARGE| Cong says survey done by NGO whose founder works in PMO BJP cites K'taka govt survey to slam Rahul

The BJP and Congress exchanged barbs over a survey conducted in Karnataka which revealed that 84.55% people believed that the election were conducted freely and fairly and 83.61 per cent found the electronic voting machines (EVMs) to be trustworthy. While the BJP claimed that this survey contradicted Congress leader Rahul Gandhi's claims of 'vote theft' and electoral malpractices, the Congress claimed that the survey was actually conducted by the Election Commission through a non-government organisation whose founder works in the Prime Minister's office.

The survey was published in Deccan Herald which claimed that it was commissioned by Chief Electoral Officer V. Anbukumar and covered 5,100 respondents across 102 Assembly constituencies in Bengaluru, Belagavi, Kalaburagi and Mysuru districts.

Incidentally, Gandhi had in a press conference in August 2024 claimed that his party's investigation into the Bangalore Central Lok Sabha election had revealed that over one lakh fake



voters were included in its Mahadevapura Assembly constituency to influence the outcome of the entire election. The BJP had won the Lok Sabha election by 32,707 votes.

However, the survey revealed that despite Gandhi's allegations of vote theft, levelled at various press conferences, interactions abroad as also through his Vote Chori Yatra during the Bihar Assembly elections, a vast majority of the electoral trusted the electoral system and the EVMs.

In light of these findings, BJP national spokesperson Shehzad Poonawalla asserted that the survey was a "tight slap" to the "propaganda" being indulged in by Gandhi. "This is the same Rahul Gandhi who has no problems with the Election Commission when Congress wins in Karnataka, Telangana and Himachal, but when he loses elections, he blames the poll body," Poonawalla said.

## Maha Cong neta likens Rahul to Lord Ram, BJP bristles

Former Maharashtra Congress president Nana Patole's remarks comparing Rahul Gandhi's work to that of Lord Ram drew a sharp response from the Bharatiya Janata Party on Thursday as it termed them "sycofantry pro max" and a "grievous insult to the faith and sentiments" of the Hindus. It was while talking to the media on why Congress leader Rahul Gandhi has not visited the Ram Temple in Ayodhya that the former MP Nana Patole had reasoned that "Rahul Gandhi is doing the work of Bhagwan Shree Ram, because Bhagwan Shree Ram's work was to ensure justice for harassed and deprived."

He had added that "Rahul Gandhi is doing the same". Moreover, in a snide remark on Prime Minister Narendra Modi's frequent visits to the Ram Temple, Patole had added that Rahul Gandhi "likes to do this service in place of doing photo session at the Ram Temple." He had also recalled how it was Rahul's father and former PM Rajiv Gandhi who was "behind the opening of the lock there..."

## Bulldozer action in Chomu after stone-pelting incident

Following the stone-pelting incident against the police in Chomu town a few days ago, the administration launched a major crackdown against encroachments on Friday and bulldozed the encroachments of those who were allegedly involved in the stone-pelting. Chomu Police Station SHO Pradeep Sharma said that notices were served regarding 20 illegal slaughterhouses and 4 illegal constructions on December 29th, but the concerned individuals did not respond to the notices, nor did they present any legal documents. Looking at this, the municipal council team demolished the encroachments.

Amid the bulldozer action, the municipal officials clarified that the demolition drive is being carried out strictly under legal provisions.

Sunil Kumar Swami, Assistant Accounts Officer of the Chomu Municipal Council, said notices were issued on December 29 concerning 20 illegal slaughterhouses and four other illegal construc-

tions. He said the parties were asked to submit valid documents or remove the structures themselves within three days. If they failed to do so, the council would move ahead with demolition and sealing under existing rules.

The action took place with the deployment of a heavy police force in the area. Many houses in the locality were found locked during the drive. At a few locations where residents were present, people chose not to speak to the media.

Regarding the action, Rajasthan Deputy Chief Minister Prem Chand Bairwa posted on X, "A strong message to those who tamper with law and order! The bulldozer action taken by the Bhanjanlal government against anti-social elements who spread unrest and disrupted peace in Chomu clearly shows that no one is above the law. There will be no compromise on peace, security, and good governance in Rajasthan. Immediate and strict action against those who indulge in rioting, violence, and damage to public property is the government's firm commitment."
