

MASSIVE WINTER STORM PARALYSES 40% OF US POPULATION

Nearly 10,000 flights cancelled; power outages spread; ice and snow stymie travel plans

DALLAS Almost 10,000 flights across the US set to take off over the week-end have been canceled as a major storm expected to wreak havoc across much of the country

threatens to knock out power for days and snarl major roadways. Roughly 140 million people, or more than 40% of the US population, were under a winter storm warning from New Mexico to New England. The National

Weather Service forecast warns of widespread heavy snow and a band of catastrophic ice stretching from east Texas to North Carolina. Forecasters say damage, especially in areas pounded by ice, could rival that of a hur-

ricane. Ice and sleet that hit northern Texas overnight were moving toward the central part of the state on Saturday, the National Weather Service in Fort Worth said. Expecting ice and hazardous conditions, officials

said all schools in Houston will be closed on Monday. "Dangerously cold temperatures and wind chills are spreading into the area and will remain in place into Monday," the agency said on X. Low temperatures

will be in the single digits for the next few nights, with wind chills as low as minus 12 degrees Fahrenheit. More than 95,000 power outages were reported across the country on Saturday morning.
