

Delhi HC orders Indian passport for stateless Tibetan woman

THE DELHI High Court on February 2 held that a stateless India-born Tibetan refugee, living in Switzerland as a "stateless" person, qualifies as a "citizen of India by birth" in terms of the Citizenship Act, and is entitled to an Indian passport.

Yangchen Drakmargyapon, "stranded" in Switzerland since 2014, was born in Dharamshala in 1966, and her eldest son was born in Darjeeling in 1995. With no valid travel documents as of the date, "effectively making her stateless," she moved the Delhi HC through her counsel, Sanjay Vashisht, in 2024 seeking the court's direction that she be granted an Indian passport, in recognition of "citizenship by birth" as provided under the Citizenship Act. The urgency followed the demise of her husband, who wanted his ashes sent to rest in India. The Ministry of External Affairs (MEA) opposed Yangchen's petition.

Justice Sachin Datta, in an order made public Tuesday, found that Yangchen "squarely satisfies the requirement of Section 3(1)(a)" of the Citizenship Act, since she was born in India on or after January 26, 1950, and before July 1, 1987. Relying on the past judicial precedents, where Tibetan refugees born in India within the cut-off dates as prescribed under the Act have been recognised as Indian citizens, the court also held that MEA's argument that Tibetan refugees with identity certificates amount to voluntary renunciation of Indian citizenship was "misconceived".

Six minors accused of gangraping classmate in Odisha detained

THE BALANGIR district police in Odisha detained six minors for allegedly raping one of their classmate and recording it on their mobile phone.

The incident happened on December 27, and the victim's family approached police on Tuesday after a purported video of the incident went viral.

According to police, the minor was allegedly gangraped while she was returning from tuition classes. The victim was allegedly lured to a place by one of the accused. One of the accused allegedly filmed the incident and circulated it on social media.

Balangir SP Abhilash G said police have seized a mobile phone that contains "scientific evidence". A case has also been registered under the IT Act.

"Six persons have been taken into custody. Though the mastermind is a 17-year-old, we will treat him as an adult during the trial of the case," said the SP.

IG Himansu Lal said police would try for a fast trial of the case.

Main suspect in mistaken-identity killing from 2024 'spotted in Dubai'

New Delhi: Fugitive gangster Sachin Golu, a prime suspect in the mistaken-identity killing of a Delhi businessman in Farsh Bazar in 2024, has fled India via Nepal using a fake passport and is now believed to be in Dubai, sources in the Delhi Police said.

Golu, against whom the Delhi Police has issued a Look Out Circular, had gunned down businessman Sunil Jain, along with associate Naveen Kasana, in December 2024.

Two men had allegedly fired nearly half-a-dozen bullets at Jain who was returning home on his two-wheeler from a morning walk at Yamuna Sports Complex. Investigation later revealed that it was a case of mistaken identity, with the target allegedly being someone from Golu's rival gangs.

"Sometime after Jain's murder, Sachin Golu crossed into Nepal using forged documents. From Nepal, he first went to Thailand and then to Dubai. He has been spotted in Dubai," a senior Delhi Police officer told The Indian Express.
