3. The Vehicle will be sold over & above the Reserve Price fixed by the Bank and minimum increment over the reserve price shall be **Rs.5,10,000/- (Five Lakhs Ten Thousand Only)** for each property.

The intending bidders shall deposit Earnest Money Deposit (EMD) of **RS.51,000/- (Rupees Fifty One Thousand Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or before **23-02-2026 at 04:00PM**.

6. Auction would commence at Reserve Price, as mentioned above.
