# Accused in law college shooting dies

**Tarn Taran:** The accused in the Feb 9 shooting incident at Mai Bhago Law College here died on Wednesday night.

Prince Raj Singh had turned the gun on him soon after shooting dead his classmate Sandeep Kaur inside their classroom and in front of their classmates. Senior SP Surendra Lamba confirmed Raj succumbed to his injuries at the hospital where he had been admitted in a critical condition since Monday. His death was announced on Wednesday night.

His body was taken to his native village on Thursday, where he was cremated in the

presence of grieving family members. The shooting had spread panic across the campus. Both students were in their first semester, and the sudden gunshots left classmates and faculty members stunned. According to police, Sandeep died on the spot after being shot, while Raj sustained a critical head injury.

He was rushed to the hospital, where doctors fought to save his life for two days. Despite intensive medical care, he could not survive.
