The successful bidder shall deposit 25% of the bid amount (inclusive of Pre-Bid EMD already paid) within 5 days inclusive of Bid day, of the sale being knocked down in his / her favour and the balance within 15 days from the date of acceptance of offer, in the same account, where Pre-Bid EMD amount is deposited.
