Description of Property

All that Piece and Parcel of Land situated In Tiruppur Regn.District, in Kaniyur Sub-Regn.District, in Maddathukulam Taluk, In Vedapatti Village, in S.F.No.101/1A as per the updating S.F.No.101/5B an extent of Punja acre 0.11 ½ of lands, in this a part of Eastern side portion along with RCC roof residential building is situated within the following boundaries:-
