Putin accepts Xi's peace plan to end Ukraine war

Two leaders agree to boost cooperation to counteract Western power

MOSCOW

RUSSIAN President Vladimir Putin said on Tuesday a Chinese peace plan could provide a basis for a settlement of the fighting in Ukraine when the West is ready for it.

Speaking after talks with Chinese leader Xi Jinping, Putin chargsd that Ukraine's Western allies so far have shown no interest in that.

The Chinese plan calls for a ceasefire and negotiations but does not contain any mention of Russia withdrawing its troops from Ukrainian territory that are occupied.

when Kyiv and the West will be ready for it," Putin said after talks with Xi. "However, so far we have not seen such readiness on their part."

Meanwhile, at a Kremlin summit with Putin. Chinese leader Xi promised to strengthen coordination with Russia. Both nations seek allies to counteract Western power and the two are expected to sign a raft of economic cooperation agreements. Putin called the talks "meaningful and frank" and said that Russia, which has been largely cut out of European markets because of sanctions, would be able to meet China's "growing demand" for energy. "I propose strengthening our coordination and cooperation." Xi said between two

rounds of talks in the Kremlin in footage shown on Russian state television. Putin said he was "convinced that our multilevel mutually beneficial cooperation will strengthen further".

The Chinese leader's Moscow visit has been viewed as a boost for Putin, who is subject to an International Criminal Court warrant over accusations of unlawfully deporting Ukrainian children. China has sought to portray itself as a neutral party in the Ukraine conflict, but Washington has said Beijing's moves could be a "stalling tactic" to help Moscow. The United States has accused Beijing of mulling arms exports to Moscow, claims that have been vociferously denied by China.

NEW York police tightened security Monday ahead of a possible historic indictment of Donald Trump over hush money paid to a porn actress, with the ex-president calling for mass demonstrations if he is charged. Only a couple of dozen Trump supporters attended a protest in America's financial capital on Monday evening though, as a grand jury weighs an investigation by Manhattan District Attorney Alvin Bragg over the 2016 payment to Stormy Daniels.

Trump would become the first former or sitting president to be charged with a crime if an indictment is filed — a move that would send shockwaves through the 2024 White House race, in which the 76-year-old is running to regain office.

Bragg, an elected Democrat, has not confirmed any plans publicly, but has put key witnesses in front of the jury in recent weeks and offered Trump the opportunity to testify. Trump said over the weekend that he expects to be "arrested" on Tuesday and urged supporters to "Protest, take our nation back!" although his lawyer said the comments were based on media reports and not any fresh action by prosecutors.

Pension reforms stand as Macron beats motions of no-confidence

Paris: The French government under President Emmanuel Macron on Monday survived two no-confidence motions in parliament, but still faced intense pressure over its handling of a pensions reform. The outcome prompted immediate anti-government protests, with 101 people arrested in Paris alone in tense standoffs between protesters and security forces, police said. Prime Minister Elisabeth Borne incensed the opposition last week by announcing the government would impose the pension reform without a parliamentary vote, sparking accusations of anti-democratic behaviour.
