TMC panchayat leader, husband and daughter hacked to death

Police: 3 arrested; key accused was in relationship with victim's daughter

A PANCHAYAT-LEVEL leader from Trinamool Congress (TMC), her husband and elder daughter were allegedly hacked to death on Friday in Sitalkuchi area of Cooch Behar district in West Bengal. The main accused was arrested along with two of his accomplices while he was fleeing the leader's house after they attacked the family, police said.

Police said the deceased were identified as Neelima Barman (52), Bimal Kumar Barman (68), and Runa Barman (24). The couple's younger daughter Iti (22) was also critically injured in the attack and is currently undergoing treatment at a hospital, they added.

Preliminary investigations indicate that the murders were a fallout of an alleged love affair that went wrong, said a senior

murder does not seem to have a

political link. The family was attacked by a man who was in an alleged relationship with the TMC leader's youngest daughter. After a failed relationship, the man killed the woman's family for revenge, the source added.

According to police, around 4.50 am, the accused Vibhuti Bhushan Roy allegedly entered Barmans' house along with his two accomplices and attacked the family with sharp objects.

Hearing the family members' screams, locals rushed to help and apprehended Roy. Later, Roy and his two accomplices were arrested by the Sitalkuchi police,

Police said the Neelima, Bimal and their daughters were rushed to the primary healthcare centre and then referred to the Sub-divisional Hospital where the couple were declared brought dead. Runa was later shifted to MJN Hospital in Cooch Behar but was declared brought dead. A LOCAL TMC leader was shot dead by unidentified assailants in a crowded market in Hanskhali area of Nadia district's Ranghat sub-division on Friday, police said.

The deceased was identified as Amod Ali Biswas, the TMC vice-president of Ramnagar Bara Chuparia panchayat area. The incident took place outside a tea shop at Ramnagar village where the assailants with their faces covered started firing at Biswas, leading to tension in the area.

They chased Biswas briefly before killing him on the spot, officials said. Police said they are investigating into the incident. Biswas had gone to the local market in the morning and was sitting at the tea shop.

Big names will come out once Google reveals who ran fake websites: BJP

BJP STATE president Sukanta Majumdar Friday said that he hoped that Google will cooperate with the CBI in unearthing "big names" in the school recruitment scam after reports that the central agency has written to the search engine seeking information on two fake websites used in the job racket.

Addressing a press conference in Kolkata, Majumdar said, "The CBI has written to Google seeking details of the websites. This means that some big names are involved in the scam. I am sure the search engine company will cooperate with the CBI. We feel that big names will come out in the open."

Sources said, the CBI officials, came across two websites (now defunct) that appeared like the West Bengal School Service Commission (WBSSC). The CBI has sought information on the email accounts that were used to open these websites and the IP addresses of the devices used to open them.

CORRUPTION CASE SC rejects plea against HC order protecting Soumendu Adhikari

PRESS TRUST OF INDIA NEW DELHI, APRIL 7

THE SUPREME Court has dismissed a plea of the West Bengal government challenging a Calcutta High Court order which protected Soumendu Adhikari, brother of BJP leader Suvendu Adhikari, from arrest in a corruption case, saying the petition did not warrant interference now as the charge sheet has

been filed. Soumendu, also a BJP leader, was protected by the Calcutta High Court against any probable coercive action by the West

Bengal police on January 31, 2023 in a case of alleged misappropriation of funds while allotting 14 shops at the Rangamati Cremation Ground at Contai in Purba Medinipur. The case relates to the period

when he was the chairperson of Contai municipal body.

A bench comprising Chief Justice D Y Chanrachud and Justice JB Pardiwala took note of the fact that now the charge sheet has been filed and a local court has taken cognisance of it. The court said, hence, there was no need to adjudicate the plea of the state government challenging the high court order.
