Bengal: HC stays single bench order terminating jobs of 32,000 teachers

ADIVISION bench of Calcutta High Court Friday passed an interim stay on an earlier single judge bench order, which terminated the jobs of around 32,000 teachers in West Bengal governmentaided primary schools, till the end of September or until further orders, whichever is earlier.

On May 12, the bench of Justice Abhijit Gangopadhyay had ordered the cancellation of appointment of around 32,000 candidates, who were recruited as primary teachers in 2016 on the basis of the 2014 Teacher Eligibility Test (TET). The bench had also directed the West Bengal Board of Primary Education to conduct a fresh recruitment exercise within three months. The order came on a writ application filed by some petitioners, who qualified in TET 2014 and participated in the 2016 recruitment process, but did not get the jobs. They had alleged irregularities in the recruitment process.

Passing the interim stay on the termination of jobs Friday, the division bench of Justices Subrata Talukdar and Supratim Bhattacharya, however, said the fresh recruitment process ordered by the single judge bench will continue.

The interim stay came on an appeal file by the West Bengal government and some of the affected teachers. Challenging the single bench order, the teachers said the termination of jobs without giving the affected parties a meaningful right to defend prima facie required judicial intervention.

After hearing the matter, the division bench ordered, "There shall be an interim stay on termination of jobs till the end of September 2023, or until further orders, whichever is earlier."

The court said the petitioners before the single bench had accrued a cause of action with the discovery of fresh materials by the board. As a result, it said, the single bench was within its jurisdiction to inquire into the aspects connected with the discovery of the fresh materials. It said the single bench, however, had a duty to extend the right of hearing to the appointees, who are the appellants before the division bench.

CUET-UG: Exam postponed in Manipur and J&K, says NTA

THE NATIONAL Testing Agency (NTA) on Friday deferred the second edition of the Common University Entrance Test-Undergraduate (CUET-UG) to May 26 in J&K, and to May 29 in Manipur. The exam is set to be held across the country from May 21–31. The agency said the decision on Manipur was taken in view of the law and order situation following the recent violence in the state. For J&K, the agency said, the move came as it looks to find ways for applicants to take the test without travelling outside the UT.

Several aspirants from J&K, as well as from Jharkhand, had expressed concern over being allotted examination centres in far away places despite having opted for those closer home.

Nasir Khuehami, the National Convenor of J&K Students Association, told *The Indian Express* it was impractical for many students from the UT to reach the allotted centres. "Several students...who opted for Srinagar as the centre of choice have been allotted centres in Panchkula (Haryana) and Punjab. Students from the marginalised communities are affected the most as they cannot shell out too much money to travel that far," he said.

In a statement issued late on Friday, the NTA said: "Being sensitive to the needs of candidates and to facilitate the students of J&K, the NTA is exploring the possibility of creating temporary centres in Kashmir. In view of the above, it has been decided that the CUET(UG) – 2023 will now be conducted from 26 May 2023 onwards in the UT..."

"NTA has sent an email to each candidate...attaching the public notice about rescheduling of CUET(UG)-2023 for the candidates of UT of J&K," UGC chairman M Jagadesh Kumar tweeted.

In another statement on Manipur

and Jharkhand, the UGC said: "Though all measures have been taken for allotting the candidates to their preferred cities, there are some candidates who have been allotted to a city in a neighbouring state. However, we have announced the city information slip in advance to give them time for making travel arrangements... As far as Manipur is concerned...NTA has carefully reviewed the law-and-order situation in consultation with the State Administration and contacted candidates by telephone for asking their preferred city..." "Some candidates who were not in Manipur or wanted to take the examination in another State/City are being allocated to other cities, i.e. Delhi, Guwahati, etc.... After contacting the State administration, the NTA has been advised to keep all examinations in the State of Manipur from May 29 onwards," it added.



NEW DELHI, MAY 19

THREE DAYS before the G20 tourism working group meeting begins in Srinagar on Monday, three countries – China, Turkey and Saudi Arabia – had not registered till Friday. A PTI report from Beijing quoted Chinese Foreign Ministry spokesman Wang Wenbin as saying: "China firmly opposes holding any form of G20 meetings on disputed territory... We will not attend such meetings."

There was no official word from Turkey or Saudi Arabia. However, Union Tourism Secretary Arvind Singh said the window to register would remain open till the morning of May 22. Besides India, the G20 includes Argentina, Australia, Brazil, Canada, China, France, Germany, Indonesia, Italy, Japan, South Korea, Mexico, Russia, Saudi Arabia, South Africa, Turkey, United Kingdom and United States, and the European Union.

Officials confirmed that delegates from the remaining countries have signed up for the three-day event. Besides G20 members, delegates from guest countries and several international organisations have also been invited. These include Bangladesh, Egypt, Mauritius, Netherlands, Nigeria, Oman, Singapore, Spain and the UAE. Officials said that barring Egypt, all other countries have registered to send their delegates. The Srinagar G20 meet will be the first major international event in Jammu and Kashmir since August 2019, when the state was divided into two UTs — J&K and Ladakh — and its special status under Article 370 of the Constitution was revoked.

On the sidelines, a major event will also be held to highlight film tourism, which the UT administration has been promoting in a big way in the last few years.
