#### GENERALGUIDELINES TO BIDDERS

### 1. Nature and Object of Online Sale:

- (a) The online e-auction sale is with the object of Free and Fair Sale, Transparency and for achieving best-possible recovery of public money.
- (b) All conditions of sale shall be governed by the directions of SEBI, the terms and conditions of the Tender-Cum-E-Auction, Notice of Sale dated **June 12, 2023** and the applicable provisions of law.

#### 2. Caution to bidders:

- (b) Breach of confidentiality, if any, shall result in cancellation of sale and appropriate action.
- 15. E-auction service provider may stipulate such other terms & conditions in compliance of IT Act 2000 and STQC Certification guidelines.
