Goa: Accused found guilty of 2017 rape-murder of Irish backpacker

A SESSIONS court in Goa Friday convicted Vikat Bhagat for the rape and murder of a British-Irish national, who was found dead near a beach in Goa in 2017. The case had shaken the state — the woman's post-mortem had re-

haemorrhage and constriction of the neck. The court convicted Bhagat under IPC sections 302 (murder), 376 (rape) and 201 (causing disappearance of evidence of offence, or giving false information to screen offender). The court heard the arguments on the quantum of sentence Friday and is expected to pronounce its order on the sentence on Monday.
