Shiv Bahadur Singh, **Co-Borrower: Mrs.Suman Azad Singh**, W/o Azad Singh, have borrowed money from Repco Home Finance Limited, **Dombivli Branch** against the mortgage of the immovable property more fully described in the schedule hereunder. Whereas the Borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "As is where is condition" and "As is what is condition" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the Company. - 3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.

We draw your attentions to Sec 13(8) of the Securitization Act as per which, no further steps shall be taken for transfer or sale of the secured asset, if the dues of the secured creditor together with all costs, charges and expenses incurred by secured creditor are tendered by the Borrower/s at any time before the date fixed for sale or transfer of the secured asset.
- 15. In compliance with Section 194 IA of the Income Tax Act, 1961 income tax @ 1% on the Reserve Price shall be deducted and paid under the PAN Number of the Purchaser. The bidder shall bear the 1% income tax on the bid multiplier amount and the Bank shall not take any responsibility for the same.
