• Behind 3 deaths and a car crash in Kolkata: 'Rich' business family's dwindling wealth

daughter and his sister-in-law had died by suicide.

A police team that was dispatched immediately to their house found the bodies of two women – Pranay's wife Sudeshna Dev and Prasun's wife Romi Dey – and Prasun's minor daughter, all in separate rooms in a flat on the first floor.

The Dey family, known for their upscale lifestyle and apparent vast wealth, was in reality drowning in debt, said police, adding that their house and the car had, in fact, been mortgaged.

The Dey family's once-thriving business, which employed 200-300 workers, had dwindled to a mere 30-40 employees. The factory located nearby has been shut since the incident. Lately, they could not even pay the rent of the rented factory, sources said.

The police investigation so far revealed that the Dey family had accumulated crores of rupees in debt, taking loans from seven banks and private lending agencies too. "They managed multiple loans from multiple sources by showing a higher turnover than the actual numbers," said a police officer.

"A drastic reduction in staff painted a clear picture of their sliding fortune, ultimately leading to their inability to even pay the rent for their factory," said a

police officer. Kailash Das, the family's driver, who was responsible for ferrying the children to and from school and coaching classes, said that he was unexpectedly told not to report for duty on Tuesday and that he would be notified when his services were needed again. He was also allowed to leave early on Monday, he told the police.

Das said that he was paid his salary on the 5th of every month, and based on this, he never suspected that the family was facing any financial difficulties.

"The Dey family meeting such a tragedy... That too because of financial problems is tough to believe," said Dr C K Chang, who has been running a dental clinic in the adjacent building of the said house for seven years.

"I never saw them fighting, no differences, no shouting... The ladies of the house would mostly stay indoors. The two brothers would never make any

till 2 am. I never saw or heard anyone screaming for help or anything like that on that day. I didn't hear the movement of the car even. At 10:30 am, I saw the younger brother and he was just standing facing the wall. I thought he was waiting for someone. In fact, I havent heard the two sister-in-laws fight ever. They would always keep their windows shut - day and night. I

"They were the highest contributors to the locality's Durga Puja. Infact, I remember them celebrating Diwali nicely," said Chang.

According to neighbours staying just 100 steps away, the Deys' were known for their generosity, particularly during festivals such as Durga Puja and Kali Puja, when they would make significant contributions

to the celebrations. "The family has been residing in the area for 50 years, his father PK Dey was a very nice person. He was into leather export. I never saw any one coming to their house seeking money. They were not very social and would not mingle with everyone around. Their father died six-seven years ago and mother died a few years later. His father was a responsible man... He had got both the brothers married while he was alive," said their neighbour Kaushik Das.

"Over the past two-three years they had changed. No one would interact with anyone in the neighbourhood," said a local shopkeeper.

Another neighbour, Ankit

Das, residing on the opposite flat of the adjacent building, said, "They would go and come back in cars. The children would mostly spend time on the rooftop." "They looked rich, had three

cars, they had two watchmen -

saw them celebrating anything

in a lavish way at home. Maybe they used to go out but I haven't seen guests visiting their place," another neighbour said. The CCTV footage also did not provide evidence of what exactly happened inside the house from Tuesday morning

till late night. According to po-

lice sources, the plugs of all the

CCTV cameras were found to be

unplugged. "The house has

multiple CCTV cameras but it wasn't plugged in," said an officer.

Hospital sources reveal that Pranay Dey's minor son sustained severe injuries in the car accident, with multiple bone fractures and wounds on his body. The teenager remains unconscious and may undergo another surgery, according to hospital officials. "Along with the two brothers' statements, the statement of the injured teenager is also important for the investigation," said an official.

According to sources, there are inconsistencies in the statements of the two brothers.

The police have already pointed out that the postmortem reports indicate homicide. Romi Dey and Sudeshna Dey suffered fatal incised wounds to the wrists and throats while the minor girl had multiple bruises, head trauma and signs of poisoning. Police believe the deaths occurred on February 18, within 3-6 hours of their last meal and 36-48 hours before the post-mortem

A police officer said the girl possibly died of poisoning, while the other two were likely
