

# KL assembly session cut short by seven days after protest by Oppn

Five UDF MLAs sit on a satyagraha in the well of House, protest against CM, Speaker

THE budget session of the assembly was cut short seven days ahead of schedule, following major protests by Opposition, including satyagraha by five UDF MLAs inside the House. With Chief Minister Pinarayi Vijayan moving a motion to guillotine the session, Speaker A N Shamseer ran through the proceedings and wound up the eighth session of the 15th assembly on Tuesday.

On Tuesday, the first surprise came from the Opposition at

the beginning of the session. Opposition leader V D Satheesan announced an indefinite satyagraha of five MLAs - Uma Thomas, Anwar Sadath, T J Vinod, Kurakkoli Moithen and AKM Ashraf - in the well of the House, protesting against lack of assurance from the CM on the permission of Rule 50 notice and withdrawing the non-bailable case charged against seven MLAs.

The ruling front first responded to the move with a nonchalant attitude and con-



tinued with the question hour. Though the Speaker tried to remind them about his ruling on Monday related to the members' behaviour and protests, the agitation continued.

Minister M B Rajesh also intervened and requested the speaker to take stern action, quoting rules of procedure. Each MLA and minister who spoke did not forget to criticise the protests.

The government decided to wind up the session six minutes before the end of the ques-

tion hour with Vijayan moving a motion to guillotine the remaining days of sitting.

Five bills were passed without any discussion. The bills are: The Kerala Public Health Bill - which brings all existing public health legislation under it, Kerala Finance Bill - under which ₹2 fuel cess will be implemented from April, Kerala Private Forests (Vesting and Assignments) Amendment Bill 2023, Kerala Panchayat Raj (Amendment) Bill 2023, and Kerala Municipality (Amendment) Bill 2023. Eight bills were passed in the session.

## Gang gags elderly woman, steals jewels

# K'giri farmers hail GI tag proposal for panner rose and Arasampatti coconut

FARMERS have welcomed the state government's proposal to seek Geographical Indication (GI) tag for Arasampatti coconut and Krishnagiri panner rose. J Kennedy, a coconut farmer in Arasampatti, said, "There are over 3,000 coconut farmers in Arasampatti and surrounding villages. The coconuts are exported to several states for over five decades. Arasampatti coconut tree can withstand drought-like conditions and the quality of oil is very good. The minister's proposal to seek GI tag for coconut grown in our village will encourage many more farmers. The government should also start a coconut research centre and coconut oil factory in the area."

Tamizhaga Vivasaijal Sangam president KM Ramagounder said, "GI tag proposal for Arasampatti coconut and cultivation of panner rose will benefit many farmers. Co-operative crop loan to the tune of ₹14,000 crore and interest-free co-operative loan for ₹1,500 crore will benefit the farmers. Already, ragi was procured from farmers and distributed at ration shops in Dharmapuri and Nilgiris on a pilot basis, later it was procured through cooperative societies to benefit the farmers. Fund allocation of ₹18 crore for red gram transplantation in Krishnagiri, Tiruvannamalai, Dharmapuri and Salem will help people to consume quality food."

T'PUR RYOTS UPSET AS BUDGET SILENT ON COPRA PROCUREMENT

Tiruppur: Farmers expressed disappointment over the lack of announcements related to GI Tag for Cheyyur groundnut and copra procurement. Kalanijyam Farmers Association Coordinator A Subramaniam said they expected geographical indication (GI) tag for groundnuts cultivated at Cheyyur in Avinashi, but there was no announcement regarding this. Tamil Nadu Farmers Association (Tiruppur) secretary R Kumar said, "In Tiruppur district, coconut and copra production is very high, but the price of copra has dropped. To stabilise the price, we sought procurement of coconut oil for distribution through PDS shops. But no announcements were made. We appreciate the announcement of allocation of ₹3 crore for development of nature manure from the Amaravathi Cooperative Sugar Mill at Krishnapuram in Madathukulam. There isn't any announcement for modernization of the facility. This plan is pending for 60 years. Farmers in Coimbatore too expressed disappointment over the budget. S Palanisamy, president of Tamil Nadu Vivasaijal sangam said, "We have been demanding to implement Anaimalaiyaru - Nallaru water scheme and Pandiyaru - Punnampazha scheme. But, the budget has no announcement about them."
