On 22 March 2012, troops of the 150th Battalion, CRPF, were conducting camp perimeter patrol near Chintagupha, Sukma. Amidst the crowded marketplace, a Maoist stealthily approached HC Om Prakash Ram from behind and attacked him with a sharp-edged knife before blending into the crowd and escaping. Despite an extensive search, the assailant remained elusive. HC Om Prakash Ram succumbed to his injuries, laying down his life in the line of duty.
