

ACB nabs contractual PS employee

The Anti-Corruption Bureau (ACB) in Latur has apprehended a 43-year-old contractual assistant programme officer for accepting a bribe of Rs12,000, an official said on Friday. Accused Jyotirling Baburao Chikhale (43) is serving at the Panchayat Samiti office in Renapur.

The complainant had approached Chikhale to process the revised estimate for the construction of a well under the Employment Guarantee Scheme and correct his surname in government records. However, Chikhale allegedly demanded Rs 15,000 to do the job.

After being alerted, ACB first verified the complaint. During the verification operation, Chikhale told the complainant to "give whatever you feel is right", said the official. A trap was laid and Chikhale was caught accepting Rs 12,000 from the complainant on Tuesday, the official said, adding that he has been booked under the Prevention of Corruption Act.

CRACKDOWN | May 31 deadline for residents to regularise all illegal connections; plumbers will also face action

NWCMC warns against illegal water connections

The Nanded Waghala City Municipal Corporation (NWCMC) has offered the last chance to the residents to regularise their illegal water connections by May 31. Later, cases will be registered against them with the concerned police stations for using water illegally. The NWCMC will also lodge complaints against the plumbers who will do such illegal connections from the corporation pipelines, the authorities warned. Presently, there are 64,858 legal water connections in the jurisdiction of the corporation, but it has also been found that several illegal connections are being operated. A few days ago, 17 cases of illegal water connections were registered with the Itwara Police Station.

NWCMC has implemented a special drive for the residents to regularise their illegal

water connections between May 1 and 31. If the connections are not regularised, the

water supply department will take stern action against the residents, it has repeatedly warned.

A meeting of the authorised plumbers was called at the NWCMC headquarters on Thursday, where they were warned that cases will be registered against them if they make illegal connections from the corporation's pipeline.

City Engineer Sumant Patil,

Deputy Engineer Prakash Kamble, Narendra Sujalegaonkar, Sanghratna Sonwale and other officers were present. A special cell has been established for regularising the illegal connections under the guidance of Office Superintendent Kadir. The illegal connections can be regularised after the payment of Rs4,500 to the NWCMC, the sources said.

BJP leader Dr Archana Patil-Chakurkar has urged Union Home Amit Shah to take up the proposal for a paramilitary training and fire-fighting range in Maharashtra's Latur.

Patil-Chakurkar, daughter-in-law of former Union home minister and Congress veteran Shivraj Patil-Chakurkar, met Shah in New Delhi on May 18, a release from her office stated.

The project was surveyed in 2007-08, during Shivraj Patil's tenure as the home minister, when land in Latur was identified for a dedicated fire-fighting and paramilitary training centre.

"I requested that the plan be immediately reviewed and executed," Dr Patil-Chakurkar said.

The release said the BJP leader also appealed to Shah to visit the CRPF camp in Latur and the BSF base in Chakur, stressing that upgraded training facilities and residential infrastructure could open up employment opportunities for local youth.
