IRS officer, his mother, sister found dead at Kochi residence

AN INDIAN Revenue Service (IRS) officer, his mother and his sister were found dead at his official resi-

dence in Kochi on Thursday evening. Police identified the bodies as those of Manish Vijay (44), his mother, Shakunthala Agarwal, and his sister,

The decomposed bodies of Vijay and his sister were found hanging in different rooms, while their mother's body was found on a cot. Police said the discovery was made at the official quarters of the central excise and customs department at Kakkanad in Kochi. Vijay was an additional commissioner with the central excise and customs and had most recently been working with the CGST (Central Goods and Servies Tax) audit wing in Kochi. The family hailed from Ranchi.

Police said they have registered a case of unnatural death. Vijay had gone on leave for a week but did not report to duty after the leave was over.

On Thursday evening, a junior officer at the CGST office went to look for Vijay and discovered the bodies of the officer and his sister. Police were called, and when they opened the door, they found the body of the mother.

Police are probing exactly when the deaths took place between February 13 and 20. Vijay's sister worked with the coal department.

S Shankar's assets attached over plagiarism allegations

Chennai: The Directorate of Enforcement (ED) has provisionally attached three immovable properties registered in the name of celebrated filmmaker S Shankar. amounting to a total value of Rs 10.11 crore, under the provisions of the Prevention of Money Laundering Act (PMLA), 2002. The action, taken on February 17, follows a long-standing legal battle over allegations of copyright infringement surrounding Shankar's 2010 blockbuster film, 'Enthiran' (Robot).

The ED initiated its investigation based on a complaint filed by writer Aarur Tamilnadan before the 13th Metropolitan Magistrate Court in Egmore, in Chennai city, on May 19, 2011. Tamilnadan's complaint said that 'Enthiran', starring superstar Rajinikanth and Aishwarya Rai, had copied significant elements from his original story, 'Jiguba'. The allegations extend to violations under the Copyright Act, 1957, and the Indian Penal Code (IPC), 1860.

Assam: Cong MP assaulted, CM says will boost security

SUKRITA BARUAH GUWAHATI, FEBRUARY 20

CONGRESS'S DHUBRI MP Rakibul Hussain and his personal security officers were assaulted by a group of masked men Thursday afternoon in Assam's Nagaon district while travelling on a scooter to a party meeting, leaving two of his security

officers injured. Videos of the incident showed the masked men hitting Hussain with a cricket bat, chasing him and attempting to snatch the weapon of one of his security officers.

No one suffered anything more than minor injuries, according to Assam DGP Harmeet Singh. "The SP is investigating the incident himself..." he said.

Nagaon SP Swapaneel Deka said the incident took place while Hussain was on his way to a party meeting. "He had travelled in a car from Nagaon to Rupahihat. From there, he took a scooter, and after a couple of kilometres, a gang stopped him. His security officers fired two blank rounds to disperse them. The MP is not injured and went on to attend the meeting," the SP said.

Police will do a "video analysis" to identify the suspects. "There were around 60-70 people there in the market. They did not have any party banner with them," SP Deka said.

Speaking in the Assembly, CM Himanta Biswa Sarma said Hussain's security would be increased.

Hussain said he, his PSOs and his son, Tanzil, were travelling on twowheelers in "anticipation" of attacks on their cars. "Here, we know they break cars and the SP says that breaking cars is a bailable offence... That's why we didn't bring the cars," he said.

Assam Congress chief Bhupen Borah said, "If ... police don't take action, then the people of Assam will be compelled to believe there is jungle raj in the state."
