All failed to make payment despite Demand Notice dated **21.09.2022**

As **M/s Krishna Readymade Centre (Prop: Shri Krishnapada Bhowmick, Borrower and Mortgagor)**, Smt. Bithika Bhowmick (Guarantor) W/o Sri Krishnapada Bhowmick, failed to make payment despite Demand Notice, the Authorised Officer took possession of the schedule mentioned properties under the Act on **21.12.2022** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6 (2), Rule 8(6) and Rule 9 (1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice. The amount due is **Rs. 15,08,632.00 (Rupees Fifteen Lakhs Eight Thousand Six Hundred Thirty Two Only (inclusive of up to date interest in the above account) as on 21.09.2022 with further interest, costs, other charges & expenses thereon due to the Indian Bank.**

Please take note that this is notice of **15 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **15 days**.

The date of sale is fixed as 02.04.2025 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.
