

UNION Minister for Road and Transport Nitin Gadkari will inaugurate the newly constructed Munnar-Bodimettu stretch of Kochi-Dhanushkodi National Highway on Friday at a public function to be held in Munnar at 2.15pm.

Although the inauguration of the highway was scheduled to be held on October 12, last year, the programme was adjourned later.

Apart from the highway, the minister will also inaugurate the newly built Cheruthoni bridge in Idukki.

The construction work of the new bridge in Cheruthoni had begun after the old bridge was damaged in the 2018 flood, caused as a result of the

opening of Idukki dam. Though a proposal to build a new bridge was submitted before the Union Ministry of Road Transport and Highways, it was rejected due to high cost


