# Police want to set up outpost on campus, seek nod from JU

KOLKATA POLICE have formally requested Jadavpur University (JU) administration to identify suitable locations for setting up a permanent police outpost on the campus. If established, this would be the first permanent police outpost inside a university campus in West Bengal.

The police move comes in the wake of escalating tension on the JU campus since March 1 when two students were injured after a car in Education Minister Bratya Basu's convoy allegedly grazed past them during a melee. Police have lodged an FIR against Basu, the person driving his vehicle and another professor, Om Prakash Mishra, in con-

### **HCLIFTS BAN ON RALLIES NEAR JU**

Kolkata: Justice Ghosh on Wednesday lifted the ban on political rallies near Jadavpur University, which was set to remain in effect until March 13.

The HC observed that as part of the verdict has been implemented, so the court does not want to take that responsibility itself, "From now on, if any organisation wants to do something, it will have to inform the administration. The administration will consider the permission after examining the application as before," observed the court.

The request has been formalised in a letter sent to the Jadavpur University authorities on Tuesday, a senior officer said. Discussions between univer-

sity authorities and students have so far failed to resolve the ongoing standoff. A marathon meeting held last Tuesday did not yield a conclusive outcome, with students submitting a memorandum of their demands. They are now awaiting further communication and another meeting with the university administration.

Two days ago, in a suo motu action, Kolkata Police registered an FIR against a student body, PDSF, over graffiti and posters on the Jadavpur University campus, saying the slogans were intended to incite hatred and disrupt public peace. The graffiti and posters featured slogans such as "Azad Kashmir," "Free Palestine," and "Fascism Must Burn", said police.

## Sanction more posts of security staff: JU to govt

Kolkata: The Jadavpur University has appealed to the state government to quicken the process for sanctioning the posts of 35 additional contractual security personnel, inside the campus, on a monthly salary of Rs 15,000.

As per a university official, the administration has a fund crunch, and have asked the concerned department to clear the matter by the end of this month. The official said a proposal on the same was sent to the state government last month, adding, that after the March 1 incident, a meeting on the proposal was held with the state last week.

"We asked the university to increase the number of permanent guards but they never took steps...," SFI state committee incharge Subhadip Bandopadhyay said. **ENS** 

# Police reject custodial torture charge: 'Medical reports don't concur'

THE POLICE on Wednesday rejected the allegations of torture levelled by woman student protesters at Vidyasagar University in Paschim Medinipur, saying the medical reports show otherwise.

A day ago, the High Court had directed Inspector General (IG) Muralidhar Sharma to investigate allegations of custodial torture of Left-leaning female student activists at a women's police station in the district and submit a report by March 25. The women activists were protesting over the incident on JU campus.

During the hearing of a peti-

tion filed by DSO activist Sushrita

Soren, Justice Tirthankar Ghosh Wednesday observed that the State should satisfy the court as to why an order should not be passed. The court raised concerns about how detained women were released at 2 am. "Do you have records to show how you asked the girls or ladies to leave the police station? Why did you ask them to leave at night?... This is not

a reasonable period of time to release them," Justice Ghosh said. Advocate General Kishore

Dutta, representing the police, said the women protesters were accompanied by political leaders and therefore they left the police station at 2 am. Rejecting charges of torture, use of abusive language, and caste slurs by police against detained women protesters, Advocate General Dutta told the court: "It is said that they became unconscious. But that took place during the agitation, and not at the police station... They alleged they were beaten by cane, molten wax was poured on their hands, leading to burn injuries. The petitioner has alleged severe humiliation due to her caste and that the state medical hospital refused to treat her... But X-ray says no bone injury was found. What is alleged to have happened at the police station is not sup-

"...The court should not proceed with the allegations of the petitioner only...," the government's counsel said.

# No relief to JU student, HC says 'probe to go on'

DAYS AFTER a Jadavpur University (JU) student moved a petition in the Calcutta High Court alleging harassment by police personnel, the court on Wednesday did not grant any relief to the student.

**Justice Tirthankar Ghosh**, who presided over the matter, observed that "at this stage it is not possible to give any interim order in the matter. The police can continue with the investigation as it is."

On Monday, a section of students from JU moved a petition in the Calcutta High Court alleging harassment by police personnel. The counsel of the petitioners had submitted in court that the police are repeatedly issuing summons to some students of the university citing investigation into the March 1 protests. Justice Tirthankar Ghosh had granted permission

for the matter to be filed. The petitioner, Uddipan Kundu, in his complaint had stated that the police is harass-

ing him under the guise of investigation, repeatedly summoning him and demanding that he

hand over his mobile phone. His counsel, Shamim Ahmed, submitted that, "The mobile is a personal device. It contains a lot of personal information. There is

an objection to making them public." While the counsel alleged that how could a student be treated like this, he also pointed

out that the Supreme Court has also identified mobile phones as personal devices. Justice Ghosh, after hearing the arguments said, "Your client's name is in the FIR. He is

an accused. In this situation, the court will not interfere in any way. Even if the accused named in the FIR is a student, granting any relief will send a bad mes-However, the judge asked the

police to ensure that the students get their mobile phones back and do not have to buy new phones.

The court has asked both the parties to submit the affidavits. The case will be heard again

in April.
