

While withdrawing, Maoists ambushed them by triggering an IED blast and opening indiscriminate fire. The troops swiftly took position, and a fierce encounter ensued. Constable H. N. Shivanand and Constable Sawanta Ram, fighting from the front, sustained severe blast injuries but continued to retaliate, forcing the Maoists to retreat. Later, the bravehearts succumbed to their injuries and attained martyrdom, upholding the highest traditions of courage and sacrifice.

On 28th April 1995, troops of 120 Battalion of CRPF, deployed in Jammu and Kashmir, launched a cordon and search operation in Pasri, Masjid Mohalla locality of Bhadarwah, District Doda.
