

# 'Caste Census first step towards new paradigm of development'

Govt should announce a timeline and get budgetary allocation for carrying out the census: Rahul

Congress leader Rahul Gandhi on Saturday reasserted that “Caste Census is the first step towards a new paradigm of development.”

In a post shared on his social media handle X, the Congress scion pointed out that the BJP had called the Caste Census divisive while “I called it the truth.”

“For years, we fought for it—because India cannot grow if 90 per cent of its people are excluded. Today, the Prime Minister and the government have finally been compelled to listen to the will of the people,” Mr Gandhi asserted.

The Congress had Wednesday welcomed the decision of the Cabinet Committee



on Political Affairs to approve a proposal to include caste enumeration in the next caste census as a “step in the right

direction” which the Congress has been demanding right from the beginning.

“We welcome it but want

to know the timeline by when it would be carried out,” Mr Gandhi, who is also the Leader of the Opposition in Lok

Sabha, had said asserting that the “caste-based census is a new paradigm of development.”

Claiming that “we have said in the Parliament that we will get the caste census done,” Mr Gandhi had said: “What suddenly happened that after 11 years a caste census was announced...It was our vision, we are happy they have adopted it.” He however said that he was in favour of scrapping the 50% barrier on reservation.

Mr Gandhi also demanded that the government should announce a timeline and also get a budgetary allocation for carrying out the census.

The Cabinet Committee on Political Affairs had on Wednesday approved a proposal to include caste enumeration in the next caste census.

## Tejashwi seeks OBCs-EBCs’ support; promises jobs, security, rapid development in return

Leader of Opposition in Bihar Assembly Tejashwi Prasad Yadav urged the backward and extremely backward communities to give him a chance to form the government in Bihar and promised jobs and security in return. He assured them that his government will not compromise with criminals.

He was speaking at the ‘Ati-Pichhda Jagao - Tejashwi Sarkar Banao Rally’ organised by the RJD’s Extremely Backward Cell in Patna on Saturday, to appease the Extremely Backward Communities (EBCs), which is the biggest community in Bihar with 36.01 per cent population.

Tejashwi Yadav also announced that the RJD will have more candidates from the backward communities in the upcoming assembly elections than the 2020 assembly elections.

Speaking about the caste census conducted by the



Grand Alliance government in Bihar, the RJD leader said that the reservation limit was increased to give proper representation to various communities as per their population.

He said: “People of the backward communities would have benefited from our efforts and got jobs. But the BJP leaders have got it entangled in court cases.”

Tejashwi said that the Nitish Kumar-led NDA government has been in power in Bihar for 20 years and in the Centre for 11 years, but the most backward communities are still in poverty.

He said: “Nitish Kumar’s

condition is bad. The BJP has hijacked him. He has aged, I feel pain seeing him in this condition. Now this government must be removed from power. After the assembly elections, a new government should be formed in Bihar -- a government that will work for rapid development of the backward and extremely backward communities.”

Earlier, Tejashwi was welcomed by leaders of the backward communities who also took a pledge to support the Rashtriya Janata Dal and the Grand Alliance in the politics of change under the leadership of Tejashwi Yadav.
