Russian Def Ministry says five drones were shot down in the capital

KYIV

A rare drone attack jolted Moscow early Tuesday, causing only light damage but forcing evacuations as residential buildings were struck in the Russian capital for the first time in the war against Ukraine. The Kremlin, meanwhile, pursued its relentless bombardment of Kyiv with a third assault on the city in 24 hours.

The Russian Defence Ministry said five drones were shot down in Moscow and the systems of three others were jammed, causing them to veer off course. President Vladimir Putin called it a "terrorist" act by Ukraine.

Putin said that Moscow's air defence had worked in a satisfactory manner, noting that the attacks were Kyiv's "response" to a Russian strike on Ukraine's army intelligence headquarters. He said Ukraine was trying to "frighten" Russians.

"We have spoken about hitting command centres (in Ukraine)," the Russian president said. "In response, the Kyiv regime has chosen a different path, the path of trying to frighten Russia, frighten the citizens of Russia and of strikes on residential buildings." While Putin claimed Tuesday's Kyiv attack was in response to Russia striking Ukraine's military intelligence headquarters days earlier, Andrii Cherniak, a Ukrainian intelligence representative, said the Kremlin's forces failed to hit the building because its

Imran to be tried in military court; PM rules out talks

ISLAMABAD

PAKISTAN'S Interior Minister Rana Sanaullah on Tuesday said that Imran Khan will be tried in a military court as he was the "architect" of the May 9 incidents. Appearing on a *Dawn News* show, Sanaullah also accused Imran of personally carrying out the planning of the attacks on military installations before his arrest on the day. There was evidence to prove the claim as well, the minister added.

> When asked if Khan would be tried in military court, he said, "Absolutely, why shouldn't it? The programme that he made to target the military installations and then had it executed, in my understanding it absolutely is a case of a military court."

"His supporters chanted a slogan that 'Imran Khan is hearing explosions before our red line,' and the planning and preparation were done dawn. Police were seen work- on Imran Khan's initiative and instigation...He is the architect of all this discord," he said. "(The evidence) is documented, it is in tweets and his messages," he added. Meanwhile, PM Shehbaz Sharif hinted that his government was unwilling to talk with Imran Khan's Pakistan Tehreek-e-Insaf party, saying the "anarchists and arsonists" who wear the garb of politicians and attack the symbols of the state do not qualify for a dialogue. India extends \$1 bn credit line to SL for another year

COLOMBO: India on Tuesday extended its under-utilised \$1 billion credit line to Sri Lanka for another year to help the island nation hit hard by an unprecedented economic crisis procure much-needed food, medicine and other essential items. An agreement was signed between the State Bank of India (SBI) and the Sri Lankan government for \$1 billion credit facility in March last year. "India reaffirms its commitment to the people of Sri Lanka. The Amendment Agreement signed in presence of Honourable Minister @ ShehanSema today will enable Sri Lanka to use the \$1 billion Indian credit facility for the procurement of medicine, food, and other essentials for one more year," the Indian High Commission in Sri Lanka tweeted. "Beyond the original duration, that is, till March 2024. The facility was extended by India through @TheOfficialSBI in response to a specific request from GOSL and forms a part of the multi-pronged assistance of \$4 billion provided by India last year," it said. Since last year, the credit facility has been used for urgent procurement of fuel, medicine, food items and industrial raw materials, as per the requirements and priorities of Sri Lanka. PTI

Court backs same-sex marriage, says govt's policy is unconstitutional

A Japanese court ruled on Tuesday that the government's policy against same-sex marriage is unconstitutional, in a closely watched decision that supporters say is a step toward marriage equality.

The Nagoya District Court in central Japan, however, rejected a request by a male couple that the government pay them \$7,100 each in compensation for the unequal treatment they face because the current system does not recognise them as legally married.

The ruling is the second that found that the government's denial of samesex marriage violates the constitution, while two other decisions did not. The rulings can be appealed to the Supreme Court.

In his ruling, Judge Osamu Nishimura said the current system that excludes same-sex couples with no legal protection for their relationship is unconstitutional and there is no room for government discretion, Kyodo News reported.

Supporters cheered outside the court, waving rainbow flags and holding signs saying, "Another step toward marriage equality."

Asato Yamada, a lawyer for the plaintiffs, said the court's ruling said clearly that not allowing same-sex marriage violates the guarantee of equal rights under Article 14 of the constitution, and that Article 24 provides freedom to marry by not specifying a prohibition on same-sex marriage. "It's a major step toward achieving marriage equality," he said.

"The judicial branch, on behalf of the rights of minorities, raised its voice and it will be a strong message to the government," he said. "The message is that the government should resolve problem immediately."

Japan is the only member of the G7 industrialised countries that does not recognise same-sex marriage. AP
