The undersigned hereby give notice to the borrowers/defaulters and general public that the Bank has decided to sell on 11/07/2025, the property described herein below on "AS IS WHERE IS" "AS IS WHAT IS" & "WHATEVER THERE IS" basis under Rules 8 & 9 of the said Rules for realizing the dues of Rs.52,99,979.90 (Rupees Fifty Two Lakhs Ninety Nine Thousand Nine Hundred Seventy nine and Paise Ninety Only) as on 04/06/2025 along with further interest, charges and cost thereon from 04/06/2025 due from the borrowers under housing loan account No 15757300000120 , Home Plus Top Up Equity loan with number 13587600002910 , CC Federal Easy Business loan with Loan Account number 13585500003061 and GECL loan with Loan Account number 13586900001325 with Branch: Dombivli of The Federal Bank Limited and thus the undersigned hereby invites tenders/e-bids from interested parties for purchasing the property subject to the terms and conditions mentioned hereunder.

Description of Property

All that piece and parcel of residential Flat No. 202, admeasuring 720 Sq. Ft. Super built up area, on 2nd Floor of Wing F, in the building known as Lodha Vihar CHSL, Bhopar Road, Dombivli (East), situated at Survey No. 37/15, admeasuring 3590 sq. meters, at Mouje Bhopar, Taluka Kalyan, Dist. Thane, within the limits of Grampanchayat and within the Registration Dist. Thane, Sub. Registration District Kalyan and bounded on the East by Open Land, on the South by E Wing, on the West by Society Garden and on the North by Road.

6. The EMD shall be remitted through EFT/NEFT/RTGS to the Federal Bank account no. A/c No 14030051030001, IFSC Code No. FDRL0001403 as mentioned above for Rs.3,83,325/- (Rupees Three Lakhs Eighty three Thousand Three Hundred and Twentyfive Only), before 3.00 PM on 09/07/2025, being earnest money deposit (EMD) equivalent to 10% of the Reserve Price of the property, which is refundable if the tender is not accepted.
