Description of property

All that piece and parcel of the property situated at East Godavari District, Kadiyam Sub-Registrar, Rajahmundry Rural Mandal, Bommuru Gram Panchayathi, Bommuru Village, Z-Meraka, R.S.No.82/6, in it landed property consisting of Ac. 0.77 cents, in it after excluding the South – West corner landed property consisting of Ac. 0.17 cents, the remaining landed property consisting of Ac. 0.60 cents was divided and laid out as plots as per plan. - 6. After opening the tenders, the intending bidders may be given an opportunity at the discretion of the authorized officer to have, interse bidding amongst themselves to enhance the offer price.
- 7. In case of default, all amounts deposited till then shall be forfeited to the secured creditor and the property shall be resold without giving notice.
