IAEA confirms Iran's Natanz site hit by Israeli air attacks

No signs of let-up as conflict enters fifth day with Israeli air striking on Iran

DUBAI

ISRAEL pounded Iran for a fifth day in an air campaign against its longstanding foe's military and nuclear program, as US President Donald Trump warned residents of Tehran to evacuate and suggested the United States was working on something "better than a ceasefire."

Trump left the Group of Seven summit in Canada a day early to deal with the conflict between Israel and Iran, telling reporters on Air Force One during the flight back to Washington: "I'm not looking at a ceasefire. We're looking at better than a ceasefire."

When asked to explain, he said the US wanted to see "a real end" to the conflict that could involve Iran "giving up entirely." He added: "I'm not too much in the mood to negotiate."

Trump's cryptic messages added to the uncertainty roiling the region as residents of Tehran fled their homes and the UN nuclear watchdog — IAEA— for the first time said Is-

raeli strikes on Iran's main enrichment facility at Natanz had damaged its underground section.

Israel said its assault on Iran's top military leaders, nuclear scientists, uranium enrichment sites and ballistic missile program is necessary to prevent its adversary from getting any closer to building an atomic weapon. The strikes have killed at least 224 people in Iran. Iran retali-

ated by launching more than 370 missiles and hundreds of drones at Israel. So far, 24 people have been killed in Israel. The Israeli military said a new barrage of missiles was launched on Tuesday.

The International Atomic Energy Agency said on Tuesday it believes that Israel's first aerial attacks on Iran's Natanz enrichment site had "direct impacts" on the facility's underground centrifuge halls.

"Based on continued analysis of high-resolution satellite imagery collected after Friday's attacks, the IAEA has identified additional elements that indicate direct impacts on the underground enrichment halls at Natanz," IAEA said.

Located 220 km southeast of Tehran, Natanz was protected by antiaircraft batteries, fencing and Iran's Revolutionary Guard. The underground part of the facility contains the bulk of the enrichment facilities at Natanz, with 10,000 centrifuges that enrich uranium up to 5%, experts assess.

'Gaza healthcare at G7 leaders try to salvage summit risk as fuel runs out' after Donald Trump's departure

THE World Health Organization (WHO) pleaded for fuel to be allowed into Gaza to keep its remaining hospitals running, warning the Palestinian territory's health system was at "breaking point."

"For over 100 days, no fuel has entered Gaza and attempts to retrieve stocks from evacuation zones have been denied," said Rik Peeperkorn, the WHO's representative in the Palestinian territories. "Combined with critical supply shortages, this is pushing the health system closer to the brink of collapse." he said 17 of Gaza's 36 hospitals were minimally to partially functional.


