

Tornadoes kill 23 in Mississippi, injure dozens

Emergency Management Agency says search & rescue teams deployed

ROLLING FORK

POWERFUL tornadoes tore through parts of the Deep South on Friday night, killing at least 23 people in Mississippi, obliterating dozens of buildings and leaving an especially devastating mark on a rural town whose mayor declared, "My city is gone."

The Mississippi Emergency Management Agency said in a Twitter post that search and rescue teams from local and state agencies were deployed to help victims impacted by the tornadoes. The agency confirmed early Saturday that 23 people had died, four were missing and dozens were injured.

A few minutes later, the agency warned the casualty toll could go higher, tweeting, "Unfortunately, these numbers are expected to change."

Mississippi Gov. Tate Reeves tweeted on Saturday that he was on his way to Sharkey County, whose county seat of Rolling Fork was flattened. "Devastating damage—as everyone knows. This is a tragedy."

The National Weather Service confirmed a tornado caused damage about 96 kilometres northeast of Jackson, Mississippi. The rural towns of Silver City and Rolling Fork reported destruction as the tornado swept northeast at 113 kph without weakening, racing towards Alabama through towns, including

Winona and Amory, into the night.

Rolling Fork Mayor Eldridge Walker told CNN that his town was essentially wiped out. Video shot as daylight broke showed houses reduced to piles of rubble, cars flipped on their sides and trees stripped of their branches. Occasionally, in the midst of the wreckage, a home would be spared, seemingly undamaged.

"My city is gone. But we are resilient and we are going to come back strong," he said.

The damage in Rolling Fork was so widespread that several storm chasers—who follow severe weather and often put up livestreams showing dramatic funnel clouds—pleaded for search and rescue help. Others abandoned the chase to drive injured people to the hospitals themselves.

Meanwhile, according to power-outage.us, 40,000 customers were without power in Tennessee; 15,000 customers were left without power in Mississippi; and 20,000 were without power in Alabama. AP

Four elders killed while collecting free flour in Pak

LAHORE

AT least four elderly people have died in the last few days while trying to collect free flour from the government distribution points in Pakistan's Punjab province, officials said on Saturday.

The deaths were reported after several people flocked to the government distribution points after the Pakistani government introduced a free flour scheme for the poor especially in Punjab province to beat the sky-rocketing inflation.

"Four elderly people died and several fainted in a bid to collect free wheat flour in Multan, Muzaffargarh and Faisalabad cities during the last few days," a Punjab government officer told PTI.

Co-founder of Intel and titan of Silicon Valley dies at 94

SAN FRANCISCO

GORDON Moore, a pioneer in the microprocessor industry and a co-founder of Intel, which at one time was the world's largest semiconductor maker, died on Friday at the age of 94, Intel said.

Moore was a giant in the technological transformation of the modern age, helping companies bring ever more powerful chips to smaller and smaller computers.

An engineer by training, he co-founded Intel in July 1968, eventually serving as president, chief executive and chairman of the board. In its early days, Intel was known for continuous innovation, growing to become one of the biggest, most important companies in technology. In an article in 1965, Moore first coined a theory that later be-

came known as "Moore's Law." It stated that integrated circuits would essentially double in power every year.

He later revised the law to say the doubling would occur every two years. After earning his PhD from CalTech, Moore and a colleague in 1957 joined Fairchild Semiconductor Laboratory, one of the earliest firms to manufacture commercially viable transistors and integrated circuits. As the company grew, the seeds were planted for the transformation of the peninsula of land south of San Francisco into what is now known as Silicon Valley. Moore and longtime colleague Robert Noyce struck out on their own in 1968, bringing along a third, Andy Grove, who would become a future Intel CEO. Moore retired from Intel in 2006.
