## Revanth challenges KCR over irrigation project

'KCR meets TV channels, but does not have guts to come to Assembly to answer guestion on Kaleshwaram project'

WONDERING if the Kaleshwaram Lift Irrigation Scheme (KLIS) was an engineering marvel as claimed by the previous BRS government, Chief Minister A Revanth Reddy on Wednesday challenged his predecessor K Chandrasekhar Rao to a debate on the irrigation project at the Medigadda barrage in the presence of experts, public intellectuals and people of Telangana. "The Kaleshwaram project,

which you (KCR) built by investing your brain, has collapsed. Did you design the project while you were intoxicated? If you have guts and honesty, come for a debate," Revanth said while addressing his second husting of the day at Warangal.

The TPCC chief also criticised the BRS supremo for not attending the Assembly session alleging that the latter does not have the courage to face the truth. "The Leader of Opposition, who has 10 years' experi-

ence of serving as chief minister, chose not to attend the session and forgo the chance to speak on people's issues as he was afraid of the Congress government questioning his loot for 10 years. KCR does not have the courage to come to the Assembly and look into my face. However, he leisurely goes to a TV channel and sits there for four hours," Revanth said.

Accepting the challenge to implement crop loan waiver by August 15, he asked Siddipet MLA T Harish Rao of the BRS to get ready with his resignation letter. Stating that though KLIS was constructed at an estimated cost of ₹1 lakh crore, Revanth asserted that the main components such as Medigadda, Sundilla and Annaram were damaged and remained defunct. On nominating Kadiyam Kavya for the Warangal Lok Sabha seat, the TPCC president said that he sent senior party leaders to meet Station Ghanpur MLA Kadiyam Srihari with a request to join the Congress.

# Three policemen suspended for demanding bribe in Chennai

CHENNAI: Tambaram city police commissioner Amalraj has suspended three police personnel—head constable Shankar and two other constables — attached to the Manimangalam police station on charges of demanding a bribe of ₹50,000.

Following information from locals that liquor bottles were being sold illegally at Salavakkam in Kanchipuram, head constable Shankar along with the two constables Ganesh and Anandaraj, had gone to the spot. As per police, they found Perumal (48) selling liquor, following which they beat Perumal up and

took some liquor bottles and ₹2,000 from him. Later, they allegedly demanded ₹50,000 to not file a case. "The man told the three that he did not have the money they were asking for, but would be able to arrange ₹30,000 as soon as possible. Taking his word for it, the three men left the spot with ₹2,000 and the liquor bottles," said a police source. The incident came to light after Perumal sought treatment at a nearby private hospital for the wounds inflicted by the policemen.

## 5-day heatwave warning in Karnataka

THE India Meteorological Department (IMD) has issued a heat wave alert for most parts of Karnataka for five days from Thursday and has advised people to avoid venturing out between 11am and 4pm.

It has issued hot and humid weather along with heat wave conditions during the period

for most parts of India, including Konkan and Goa, Andhra Pradesh, Karnataka, Telangana, Puducherry, Tamil Nadu and

> The department has also issued an orange alert for Karnataka -- high mercury levels and increased likelihood of heat-related illness among those who get exposed to the scorching sun for long.

Health concern alerts for vulnerable people have also been issued. Director-in-charge of IMD Bengaluru N Puviarasan said the heat wave alert will be issued when the maximum temperature crosses 40 degrees Celsius or when the temperature of a particular district is 4.5 degrees Celsius above normal.

The heat wave alert and warning have been issued for districts including Vijayapura, Yadgir and Koppal.

#### Two arrested for murdering chef in Thanjavur



Thanjavur: Medical College police on Wednesday arrested two persons for allegedly murdering a chef and decamping with his bike, mobile phone, and cash. The incident came to light when the victim S Prakash (40), who was working as a chef in a restaurant in Rahman Nagar, did not return home on April 16. A grievously injured Prakash was found

the next day near the Rajah Serfoji Government College playground. He was taken to Thanjavur Medical College Hospital where he died. The police registered a case of suspicious death and launched a probe. Using CCTV footage, police identified the culprits and arrested K Tamil Needhi (29), an auto driver, and R Praveen (28).
