RUSSIA launched 122 missiles and dozens of drones against Ukrainian targets, officials said on Friday, killing at least 27 civilians across the country in what an air force official called the big-

gest aerial barrage of the war. At least 144 people were injured and an unknown number were buried under rubble during the roughly 18-hour onslaught, Ukrainian officials said. A maternity hospital, apartment blocks and schools were among the buildings reported damaged across Ukraine. Ukraine's military estimated that Russia had fired 158 missiles and drones on Ukraine and 114 of them had been destroyed.

The result was "the most massive aerial attack" since Russia's invasion in February 2022, Air Force commander Mykola

Oleshchuk said. It topped the previous biggest assault, in November 2022 when Russia launched 96 missiles, and this year's biggest, with 81 missiles on March 9, according to air force records. The attack hit six cities, and reports of deaths came in from across the country.

In Dnipro, four maternity hospital patients were rescued from a fire, five persons were killed and 20 injured.

In Odesa, falling drone wreckage started a fire at a multistory residential building, as per regional head, Oleh Kiper. Two persons were killed and 15, including two children, were injured, he said. The mayor of Lviv, Andrii Sadovyi, said one person was killed there, with three schools and a kindergarten damaged in a drone attack.

Local emergency services said 30 people were injured. Kharkiv faced around 20 strikes, killing three employees at a civilian enterprise and wounding 11. Several dozen missiles were launched towards Kyiv, with more than 30 intercepted, said Serhii Popko, head of the Kyiv military administration. Three

persons were killed. Six were killed and 28 wounded said Sergiy Lysak, the governor of Dnipropetrovsk region where a shopping mall, private houses and buildings were hit.

# Shots fired at probe launched

CANADIAN police have launched an investigation into reports of shots fired at the residence of an Indian-origin businessman in Surrey in the British Columbia province, causing damage to the property. According to several media reports, gunshots were fired at the residence of the son of Satish Kumar, the president of Lakshmi Narayan Mandir, in Surrey on Wednesday.

The temple was in the news when its members last month countered a protest of the secessionist group Sikhs for Justice against the killing of Khalistani separatist Hardeep Singh Nijjar on June 18 in Surrey. A press release issued by police on Thursday said that Surrey Royal Canadian Mounted Police (RCMP) is "investigating a report of shots fired at a residence in the early morning of December 27."

Police remained in the area, examining the scene, speaking with witnesses and canvassing the neighbourhood.

# Israel bombs south Gaza home of temple as Hamas officials due head in Canada, in Cairo for truce talks

## **GAZA STRIP**

ISRAEL pounded south and central Gaza on Friday as Egypt was to host a high-level Hamas delegation for talks to try and end the nearly 12-week

The Israeli military said its forces "are extending operation in Khan Yunis" in the coastal territory's south, and had "eliminated dozens of terrorists" across Gaza over the past 24 hours. AFPTV footage showed smoke billowing over Rafah, near Egypt, following fresh strikes early Friday.

Sources close to Hamas say Egypt's three-stage



plan provides for renewable ceasefires, a staggered release of hostages in exchange for Palestinian prisoners in Israel, and ultimately an end to the war. Meanwhile, tens of thousands of Palestinians streamed into an already crowded

town at the southernmost end of Gaza in recent days, according to the UN, fleeing Israel's bombardment of the centre of the strip, where hospital officials said dozens were killed on Friday.

People arrived in Rafah in trucks, in carts and on foot. Those who haven't found space in the already overwhelmed shelters have built tents on the roadsides. "People are using any empty space to build shacks," said Juliette Touma, director of communications at UNRWA. "Some are sleeping in their cars, and others are sleeping in the open." Agencies
