Death toll rises to 2 in Jabalpur blast incident: A team of National Security Guard (NSG) began investigation into the Jabalpur blast incident, which killed people, a police official said on Saturday. The blast occurred in a scrapyard located near Khajri Khiriya bypass under the jurisdiction of Adhartal police station in Jabalpur district at around 12 pm on Thursday (April 25).
