# **CBI starts Odisha** train crash probe, speaks to rail staff

Causing death by negligence among **IPC sections in FIR** 

**RAVIK BHATTACHARYA** Bahanaga, June 6

**AS PART OF** its probe into the Odisha train accident, the Central Bureau of Investigation on Tuesday visited the Bahanaga railway station, its panel room, record room and relay room, and spoke to staff present there.

The June 2 incident involving two passenger trains and a goods train claimed 275 lives.

The CBI has started its investigation based on an initial FIR registered by the Government Railway Police (GRP) at Balasore police station.

It has been filed against unknown persons under IPC sections 304 A (death by negligence), 337 (negligent and rash act endangering human life), 338 (causing grievous hurt) and 34 (act with common intention).

Sections of the Railway Act 1989 have also been invoked, including 153 (wilful neglect endangering safety of persons travelling in railways), 154 (endangering safety of persons travelling in railway by rash negligent act or omission) and 175 (any railway servant on duty endangering the safety of any person).

In a press statement, the CBI said it has "registered a case on the request of the Ministry of Railways, consent of the Odisha Government and further orders

from DoPT (Govt. of India)". A six-member CBI team arrived at the site of the accident around 11 am and inspected it, before visiting Bahanaga Bazar railway station, where a huge contingent of railway police was already present.

Investigators first checked the panel room of the station, which displayed the signalling system. They later spoke to officials in the record room, and were also seen inspecting the railway station. All officials working at the railway station were present.

According to sources, the CBI has asked the Railways for documents and physical and digital logs from before and after the accident.

Agency officials have also started recording statements of officials present at the station.

The panel room, which doubles up as the station manager's room, was the focus of the probe. It houses the panel board and video display unit which runs the signalling system for all passing trains.

Sources said the station premises do not have CCTV

According to sources, the Bahanaga Bazar station has one station manager and three station superintendents, apart from other staff.

The station superintendents and station manager generally take turns manning the panel

Sources said the station superintendent who manned the panel on the evening of June 2 was also taken to Kharagpur to depose before the Commissioner of Railway Safety.

Meanwhile, at the railway crossing near the site of the tragedy, workers were seen putting up new boom barriers as a huge contingent of policemen stood guard. A staff member from the station, speaking on condition of anonymity, said: "I was scheduled to be on duty that evening. I had to attend a marriage ceremony and took leave. Someone else was at my place."

# Brothers facing fraud charges in India flourish in Nigeria

ATA CEREMONY in November, the Nigerian government celebrated the discovery of as many as 1 billion barrels of oil in the country's arid northeast, almost 1,000 kilometers (621 miles) away from the crude-rich Niger Delta. The state's partners in the multi-billion dollar project in the impoverished, landlocked corner of the country is a company founded by two brothers from India. The siblings have built the largest independent oil company in Africa's biggest crude producing nation even as India pursues them as criminals — accusing them of perpetrating "one of the largest economic scams in the country." Now, as newly elected Presi-

dent Bola Tinubu sets ambitious

targets for Nigeria's hydrocarbons sector, companies created by the brothers, Nitin and Chetan Sandesara, seem poised for an increasingly prominent role — especially as international oil giants such Shell Plc and ExxonMobil Corp. retreat from the West African country. "This discovery will provide a multiplicity of opportunity and great prosperity for Nigeria," Tinubu said at the November event. Sworn in on May 29, he was the ruling party's presidential candidate at the time. The selection of a firm owned by the family of the duo branded as fugitives by India to drill wells for the project is just the latest sign of how Nigeria has provided the brothers a haven, effectively insulating them from troubles back home. Indian Prime Minister Narendra Modi's government has accused the tycoons of absconding after defrauding public banks of more than \$1.7 billion. Nigeria has refused

them.

India's request to extradite



India in 2017, deny cheating their lenders and say they are victims of political persecution. Having ventured into the Nigerian oil industry almost 20 years ago when they won two onshore licenses in the delta, the brothers — faced with problems in India — have shifted their focus to Lagos. They even applied for

Nigerian citizenship, according to India's Central Bureau of Investigation, or CBI, the country's top investigating agency.

It's not clear if they succeeded. The brothers' lawyer and Nigerian authorities didn't respond to queries on the matter. While the brothers fight fraud charges and non-bailable

warrants from India, the Sandesara businesses are flourishing in Nigeria. The African nation refused to arrest them four years ago saying the Indian allegations "appeared to be political in nature," according to a letter published by the Organised Crime and Corruption Reporting Project.

In India, the brothers' private jet, swanky cars and star-studded parties at a 60,000-squarefoot farmhouse in Ampad village in Gujarat routinely provided fodder for tabloids and social media sites, according to news outlet The Print. From a sanctuary on Lagos' upscale Victoria Island, one of their Nigerian companies has continued that glitzy tradition,

sponsoring annual Diwali celebrations that are the talk of the city's small Indian community, even flying in Bollywood singers like Shreya Ghoshal to perform. The family's Nigerian oil and gas business — with the slogan "Success is Natural" — is thriving. The group's subsidiaries — Sterling Oil Exploration & Production and Sterling Global Oil Resources. pump about 50,000 barrels of crude a day in the delta via contracts with the state-owned Nigerian National Petroleum Another unit expects to bring a third block into production this year that will eventually raise total daily output to above 100,000 barrels. — BLOOMBERG
