Whereas the **Borrower: Mr. Kaja Neela Venkata Krishna** S/o, Mr. Kameswara Rao, **Co-Borrower: Kaja Lakshmi Sunitha** W/o, Mr. Neela Venkata Krishna, **Guarantor: Mr. B. Satish** S/o, Mr. Subba Rao, borrowed money from Repco Home Finance Limited, **Ongole Branch** against the mortgage of the immovable property more fully described in the schedule hereunder. Whereas the Borrowers having failed to pay the dues in full, the secured creditor, Repco Home Finance Limited has decided to sell the under mentioned secured asset in "**As is where is condition**" and "**As is what is condition**" under Section 13(4) of the Act read with Rules 8 & 9 of the Security interest (Enforcement) Rules 2002 for realization of the debts dues to the Company. The dues of the Borrower vide Loan Account No. **1661873000387** being **Rs. 38,58,938/-** as on **27.03.2025**.
