Total extent of 1.58 Ares or 3.90 cent or 1702 sq.ft. of land and building has got all usual pathway rights and easement rights relating thereto.


Terms and Conditions of E-Auction

- 3. The EMD amount is refundable **without interest** to the bidder if the bid is not successful.
- 4. Offer without EMD and below the reserve price will be rejected.
