LEADER of Opposition in the Legislative Council Kota Srinivas Poojary said on Wednesday that CM Siddaramaiah should order an investigation into senior Congress leader and MLC B K Hariprasad's recent 'controversial' statement. Hariprasad had said that there may be a 'Godhra-like' incident in Karnataka ahead of the consecration of Lord Ram's Idol in Ayodhya.

Speaking to reporters here on Wednesday, Kota Srinivas Poojary said that negative comments by Hariprasad aim at stoking anxiety in the public. "In the Godhra incident, 59 devotees were charred to death in a train in 2002. But if Hariprasad is recalling it now and says similar incidents may repeat, then the Congress party will be held responsible for any such incident as that party has been vehemently opposing the construction of Ram Mandir in Ayodhya," he said. "If a Congress leader can foretell about the 'Godhra-like' incident now, it appears to me that the Congress is hatching a conspiracy," he lamented.

To a query on reopening of cases against Karsevaks in Hubballi, the Pejawar seer said the Ram Mandir is being built now and a Karsevak was arrested. "This is an attempt to suppress Hindus. Why do we need this development now? That could lead to chaos. The government should make sure that there is no issue because of this," he said. ENS
