- 2. **Bidding will be for INDIVIDUAL Vehicle basis** and separate EMD to be paid for each vehicle.
- 3. The auction will be "Online E-auctioning" through website <a href="https://bob.auctiontiger.net">https://bob.auctiontiger.net</a>. Bidders are advised to go through the website for detailed terms and conditions before taking part in the e-Auction sale proceedings.

The Intending Bidder / Purchaser is required to send the copies of the following documents before last date of submission of the bid(s) viz. on <a href="mailto:traveldesk.bcc@bankofbaroda.com">traveldesk.bcc@bankofbaroda.com</a> (i) Copy of the NEFT/RTGS Challan / Detail of RTGS/NEFT ii) Copy of PAN Card; iii) Proof of Identification (KYC) viz. self-attested copy of Voter ID Card / Driving License / Passport / Aadhar Card etc. iv) Copy of proof of address; without which the bid is liable to be rejected.
